AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND SAN MATEO COUNTY RESOURCE CONSERVATION DISTRICT

THIS AMENDMENT TO THE AGREEMENT, entered into this 25th day of

September, 2018, by and between the COUNTY OF SAN MATEO, hereinafter called

"County," and the San Mateo County Resource Conservation District, hereinafter called

"Contractor";

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for services related to water quality improvement and natural resource protection on June 27, 2017; and

WHEREAS, the parties wish to amend the Agreement to increase the scope of services provided to include various waste reduction and stakeholder engagement programs and activities.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3. Payments of the Agreement is amended in its entirety to read as follows:

In consideration of the services provided by Contract in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed SIX HUNDRED TWELVE THOUSAND EIGHT HUNDRED THIRTY-FIVE DOLLARS (\$612,835). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.
