RESOLUTION 076017 TO ADD EIGHT POSITIONS, DELETE EIGHT POSITIONS,  
RECLASSIFY ONE POSITION, ADJUST THE SALARY OF ONE POSITION, AND  
CONVERT ONE POSITION TO CLASSIFIED VIA MEASURE D**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

**WHEREAS**, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

**WHEREAS**, San Mateo County Ordinance No. 07303 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors.

**NOW THEREFORE, IT IS HEREBY ORDERED** that the Board of Supervisors authorizes an amendment to Master Salary Resolution 076017 as follows:

**SECTION 1:** Part 14 of the Resolution is amended as indicated:

ORGANIZATION 37000 LIBRARY

1. Item E335, Fiscal Office Specialist is decreased by 1 position for a new total of 0 positions.

2. Item E030S, Accountant Series is increased by 1 position for a new total of 1 position.
3. Item K011, Library Assistant Bookmobile Operator is decreased by 1 position for a new total of 0 positions.
4. Item G228, Senior Community Program Specialist is increased by 1 position for a new total of 2 positions.
5. Item K008, Circulation Supervisor is decreased by 1 position for a new total of 6 positions.
6. Item K001S, Librarian Series is decreased by 1 position for a new total of 26 positions.
7. Item K003, Senior Librarian is increased by 2 positions for a new total of 7 positions.

#### ORGANIZATION 38000 PLANNING AND BUILDING

1. Item E337, Office Specialist is decreased by 1 position for a new total of 3 positions.
2. Item E003, Administrative Secretary III is increased by 1 position for a new total of 1 position.

#### ORGANIZATION 62400 FAMILY HEALTH SERVICES

1. Item E416S, Medical Office Assistant Series is decreased by 4 positions for a new total of 1 position.

2. Item G117, Senior Community Worker is increased by 4 positions for a new total of 13 positions.
3. Item B182S, Community Program Specialist Series – Unclassified is decreased by one position for a new total of 0 positions.
4. Item G226S, Community Program Specialist Series is increased by 1 position for a new total of 7 positions.

ORGANIZATION 66000 SAN MATEO MEDICAL CENTER

1. Salary Range for Item D157, Director of Health Information Management is set at \$66.13 – \$82.67 per hour.
