RESOLUTION: A) ADOPTING THE PLANS AND SPECIFICATIONS, INCLUDING CONFORMANCE WITH PREVAILING WAGE SCALE REQUIREMENTS, FOR THE COYOTE POINT FIRE PUMP PROJECT AT THE COYOTE PARK RECREATION AREA; AND B) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO CALL FOR SEALED BIDS TO BE RECEIVED BY THURSDAY, JUNE 6, 2019 AT 2:30 PM IN THE OFFICE OF THE COUNTY MANAGER/CLERK OF THE BOARD OF SUPERVISORS; AND C) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO EXTEND THE CALL FOR BIDS AND BID OPENING UP TO 60 CALENDAR DAYS BEYOND THE TIME AND DATE ORIGINALLY SET FORTH BY THE BOARD OF SUPERVISORS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Coyote Point Recreation Area (Park) has a private water system, which provides water to several buildings, including the CuriOdyssey Museum, and other Park features such as the rifle range, a marina, fire hydrants, irrigation systems, drinking fountains, and restrooms; and

WHEREAS, the water system is connected to two separate water utilities, one operated by the City of Burlingame and the other operated by the California Water Service Company; and

WHEREAS, the Parks Department entered into an Agreement with Bracewell Engineering Inc. (BEI) to investigate the existing water pressures and flows within the Park and provide recommendations to mitigate low water pressures and flows; and

WHEREAS, based on BEI's findings and recommendations, BEI prepared the plans and specifications for constructing a water fire pump for the water system to

provide auxiliary water pressure for the fire protection supply requirements at any given time; and

WHERAS, plans and specifications dated May 10, 2019 have been prepared and approved by the Director of Public Works for the Coyote Point Recreation Area Fire Pump Project, and said plans and project specifications have been filed in the office of the Director of Public Works (the "plans and specifications"); and

WHEREAS, the plans and specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by the Department of Industrial Relations, in the locality in which said work is to be performed for each type of workman needed to execute the contract.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that:

- 1. The plans and specifications dated May 10, 2019, for the aforesaid project, which are on file in the office of the Director of Public Works, and to which reference is hereby made for further particulars, are hereby approved and are adopted as the plans and specifications to be adhered to in letting and performing the work under a contract for said improvements described therein.
- 2. Said specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by the Department of Industrial Relations, in the locality in which said work is to be performed for each type of workman needed to execute the contract.

- 3. The Department of Public Works is authorized and directed to issue a call for sealed bids and to set the bid opening date and time on or before 2:30 p.m., Thursday, June 6, 2019 in the office of the County Manager/Clerk of the Board of Supervisors in the Hall of Justice, Redwood City, California. Said bids will be received by the Deputy Clerk of the Board of Supervisors and then transmitted to the County Manager's Office in said Hall of Justice and be publicly opened and declared.
- 4. The Director of Public Works is authorized to extend the call for bids and bid opening up to sixty (60) calendar days beyond the time and date originally set forth by the Board of Supervisors.
- 5. The Department of Public Works is further directed to cause the Notice inviting sealed bids to be published for two (2) times in a weekly local newspaper of general circulation, published in the County, and to obtain an affidavit of said publication, a copy of which shall be placed on file with the Department of Public Works.
