RESOLUTION AUTHORIZING A ONE-TIME GRANT OF DISTRICT-DISCRETIONARY MEASURE K FUNDS, NOT TO EXCEED \$926,000, TO THE CITY OF DALY CITY FOR GELLERT PARK IMPROVEMENTS, PROVIDING AN EXCEPTION TO THE CRITERIA FOR DISTRICT-DISCRETIONARY MEASURE K FUNDS TO ALLOW REPEAT FUNDING WITHIN THE CURRENT BUDGET CYCLE, AND AUTHORIZING THE COUNTY MANAGER OR HIS DESIGNEE, TO EXECUTE THE GRANT AGREEMENT

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of

California, that

WHEREAS, Measure K is the half-cent general sales tax initially approved by San Mateo County voters in November 2012, and extended in November 2016 for a total of thirty years; and

WHEREAS, the Board and County staff have conducted study sessions and

community outreach efforts to inform priorities for Measure K spending; and

WHEREAS, on May 16, 2017 the Board of Supervisors approved the fiscal year

(FY) 2017-19 **Measure K** allocation plan, which included district-discretionary funds in the amount of \$7 million in one-time loans or grants during FY 2017-19, divided equally among the supervisorial districts, for district-discretionary needs and projects; and

WHEREAS, Supervisorial District Five has requested a one-time \$926,000 grant to the City of Daly City to add a new restroom building, renovate the playground with new play structures, renovate the BBQ area, upgrade the lighting for the tennis and basketball courts and other miscellaneous improvements; and

WHEREAS, this item is consistent with the criteria for district-discretionary Measure K funds approved by the Board in December 2018; with the following exception: the subject grant would be the second grant of district-discretionary funding to the organization within the current FY 2017-2019 budget cycle, and

WHEREAS, the Board finds that the exception to the criteria for districtdiscretionary funds is warranted in this instance because it serves a different part of the community; and

WHEREAS, there are sufficient Measure K funds in the Non-Departmental Services FY 2018-19 Adopted Budget for this purpose; and

WHEREAS, it is the Board's intent for the County Manager, or his designee, to execute an agreement in the amount of \$926,000,to the City of Daly City and setting forth the terms of the grant in furtherance of the objectives set forth in the Project Summary section in this Board transmittal; and

WHEREAS, this Board has been presented with a form of the grant agreement and has examined it and approved it as to both form and content and desires to enter into the agreement; and

WHEREAS, this Board has been presented with a form of the grant agreement and has examined it and approved it as to both form and content and desires to enter into the agreement or a substantially similar agreement. **NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the Board of Supervisors approves of said grant, and authorizes the County Manager, or his designee, to execute said grant agreement.

BE IT FURTHER RESOLVED that the County Manager or designee is authorized to execute amendments to the grant agreement which modify the County's maximum fiscal obligation by no more than ten percent (10%) or \$25,000 (in aggregate), whichever is less, and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provision.
