COMMENCING (POC) AT THE MOST SOUTHEASTERLY CORNER OF THE LAND CONVEYED TO GREGORY DUKE AND WIFE IN THE GRANT DEED RECORDED JULY 1, 1998 AS INSTRUMENT NO. 1998-103548, ALSO BEING A POINT ON THE WESTERLY LINE OF HILLCREST DRIVE AND ALSO BEING MOST NORTHERLY POINT OF OAK KNOLL SEWER MAINTENANCE DISTRICT BOUNDARY ADOPTED ON JUNE 27, 1995 BY RESOLUTION No. 59466

THENCE SOUTHERLY ALONG THE WESTERLY RIGHT OF WAY OF HILLCREST DRIVE FROM A RADIAL LINE WHICH BEARS NORTH 43°48'21" WEST, ALONG CURVE TO THE LEFT, HAVING RADIUS OF 93.10 FEET, A CENTRAL ANGLE OF 50°52'19" AND ARC LENGTH OF 82.66 FEET TO TRUE POINT OF THE BEGINNING (POB)

THENCE FROM SAID POINT OF BEGINNING AROUND THE PERIMETER OF SAID PARCEL, IN CLOCKWISE DIRECTION, THE FOLLOWING SIX COURSES:

- 1. SOUTHERLY ALONG SAID WESTERLY RIGHT-OF-WAY LINE OF HILLCREST DRIVE AND SAID CURVE, A RADIAL POINT WHICH BEARS SOUTH 85°26'41" WEST AT LAST SAID POINT, SAID CURVE HAVING A RADIUS OF 93.10 FEET, A CENTRAL ANGLE OF 27°01'41" AND AN ARC LENGTH OF 43.92 FEET;

- 3. ALONG THE SOUTHERLY LINE OF SAID PARCEL, SOUTH 58°25'00" WEST, A DISTANCE OF 22.27 FEET;

- 4. ALONG THE SOUTHERLY LINE OF SAID PARCEL, NORTH 68°10'00" WEST, A DISTANCE OF 136.63 FEET TO THE BEGINNING OF A NON-TANGENT CURVE TO THE RIGHT, SAID POINT BEING A POINT ON THE EASTERLY RIGHT-OF-WAY LINE OF UPLAND ROAD;
- 5. NORTHERLY ALONG SAID EASTERLY RIGHT-OF-WAY LINE OF UPLAND ROAD AND SAID CURVE, A RADIAL POINT WHICH BEARS NORTH 87°04'53" WEST AT LAST SAID POINT, SAID CURVE HAVING A RADIUS OF 553.14 FEET, A CENTRAL ANGLE OF 8°16'42" AND AN ARC LENGTH OF 79.92 FEET;
- 6. ALONG THE NORTHERLY LINE OF SAID PARCEL SOUTH 67°49'00" EAST, A DISTANCE OF 108.29 FEET TO THE WESTERLY RIGHT-OF-WAY LINE OF HILLCREST DRIVE TO THE TRUE POINT OF THE BEGINNING
