# Mission

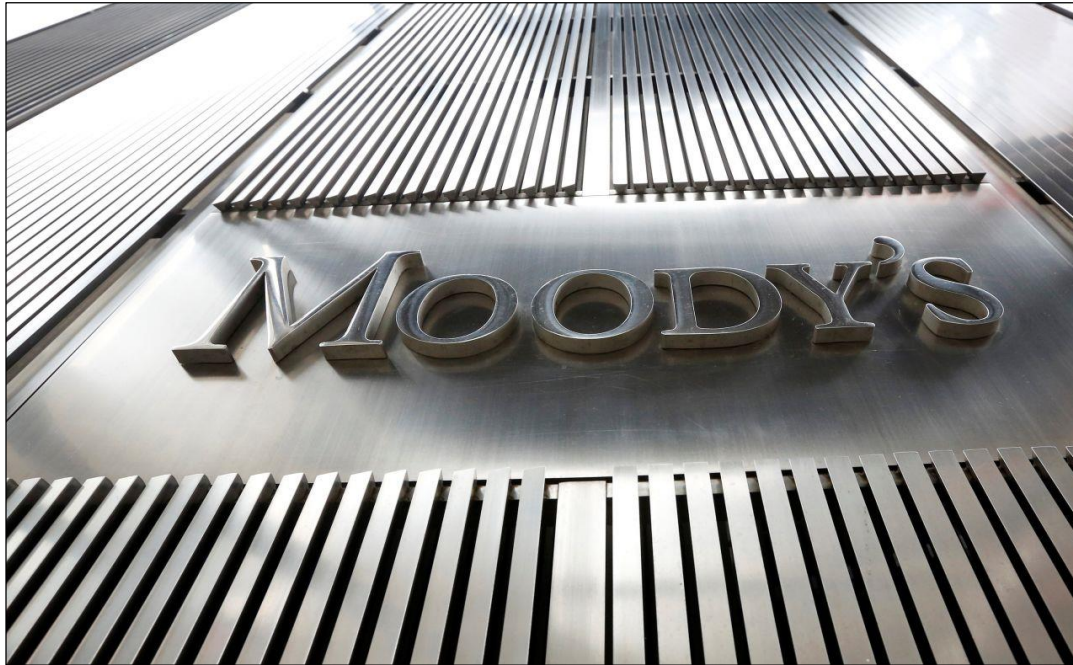

# FY 2017-19 Accomplishments

- Maintained the highest credit ratings from Moody's (Aaa) and Standard and Poor's (AAA)
- Issued bonds in the amount of \$262 million



# FY 2017-19 Accomplishments

- In 2019, introduced **AB 825** (Mullin) San Mateo County Flood Control District and **AB 738** (Mullin) Regional Housing Needs Allocation
- Supported the passage of the following County-sponsored bills: **SB 793** (Hill, Chapter 627, Statutes of 2017) and **AB 851** (Caballero, Chapter 821, Statutes of 2017)



# FY 2017-19 Accomplishments

- Established a removal defense legal services fund to support the immigrant residents of the county
- Prepared the Community Vulnerability Index
- Prepared a new Five-Year Capital Improvement Plan for FY 2019-24



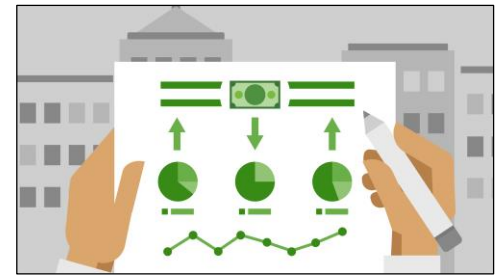

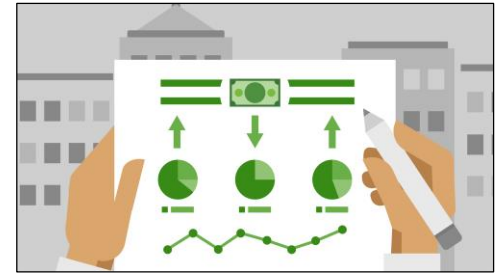

# FY 2019-21 Priorities

- Improve school reading scores so that 80% of 3rd graders are reading at grade level
