SEVENTH AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND CSG CONSULTANTS, INC.

THIS SEVENTH AMENDMENT TO THE AGREEMENT, entered into this 25th day of June 2019, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and CSG Consultants, Inc. hereinafter called "Contractor";

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for the purpose of structural, mechanical, electrical, plumbing and life safety plan check services for commercial and residential construction services on July 16, 2015; and

WHEREAS, the parties amended the Agreement six times, extending the term through June 30, 2018 and increasing the not-to-exceed amount to \$626,000; and.

WHEREAS, the parties wish to further amend the Agreement to extend the term through September 30, 2019, and increase the amount by \$125,000, for a total Agreement amount not to exceed \$751,000.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

- 1. Section 3 (Payments) of the Agreement is amended to read as follows:
 - In no event shall the County's total fiscal obligation under this Agreement exceed Seven Hundred Fifty One Thousand Dollars (\$751,000).
- 2. Section 4 (Term) of the Agreement is amended to read as follows:
 - Subject to compliance with all terms and conditions, the term of this Agreement shall be from July 16, 2015, through September 30, 2019.
- 3. Exhibit B of the Agreement is deleted in its entirety and replaced with the attached Exhibit B.

All other terms and conditions of the Agreement dated July 16, 2015, between the County and Contractor shall remain in full force and effect.

County shall pay Contractor within thirty (30) business days of receipt of a satisfactory invoice. In no event shall payment for Services exceed seven hundred fifty one thousand dollars (\$751,000).
