RESOLUTION AUTHORIZING THE CHIEF INFORMATION OFFICER OR HIS DESIGNEE TO EXECUTE AGREEMENTS WITH EACH VENDOR LISTED IN ATTACHMENT A TO PROVIDE AS NEEDED INFORMATION TECHNOLOGY SERVICES FOR THE TERM OF JULY 1, 2019 THROUGH JUNE 30, 2021, FOR AN AGGREGATE AMOUNT NOT TO EXCEED \$20,000,000, AND TO EXTEND SIX (6) EXISTING AGREEMENTS IN ATTACHMENT B UNDER THE MASTER SERVICES AGREEMENT RESOLUTION #073010 TO ALLOW FOR COMPLETION OF ONGOING PROJECTS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, in November 2013, Information Services Department (ISD) released RFP #1825 to pre-qualify a variety of select technology vendors for a broad spectrum of IT project-based needs; and

WHEREAS, on February 11, 2014, the Board of Supervisors approved Resolution #073010 authorizing the Chief Information Officer or his Designee the ability to execute Agreements with vendors, listed in Attachment A of Resolution #073010, to provide IT services through February 10, 2017, and for an aggregate amount not to exceed \$25,000,000; and

WHEREAS, on May 20, 2014, the Board of Supervisors approved Resolution #073193 to utilize Resolution #073010 for additional projects not included on Attachment B of Resolution #073010 so long as they have been approved by ISD and/or customer departments; and

WHEREAS, on January 24, 2017, the Board of Supervisors approved

Resolution #075006 amending Master Services Agreements Resolution #073010 to

add additional vendors to the pool and extend the term through February 10, 2019; and

WHEREAS, on January 29, 2019, the Board of Supervisors approved

Resolution #076409 amending of Master Services Agreements Resolution #073010 to

extend the term through June 30, 2019; and

WHEREAS, ISD would like the ability to extend six (6) Agreements, listed in Attachment B, currently in process and active under Resolution #073010. ISD requests that authority be granted to the Chief Information Officer to extend the completion dates and fiscal obligations of these agreements through the end of their corresponding projects. The aggregate amount of the extended agreements listed in Attachment B will not exceed the aggregate not to exceed amount in Resolution #070310; and

WHEREAS, on April 22, 2019, ISD released RFP #ISD-20191840 to refresh the eligible vendor pool permitted to bid on a variety of IT projects as well as establish a new term and aggregate not to exceed amount; and

WHEREAS, ISD would like to select from the pre-approved vendors, listed in Attachment A, to bid on a variety of IT needs. This would also allow ISD to authorize the Chief Information Officer or his designee to execute agreements over \$100,000 and in aggregate up to an amount not to exceed \$20,000,000; and

WHEREAS, there has been presented to this Board of Supervisors for its consideration and approval the form of this Resolution the term of July 1, 2019 to June 30, 2021, for an aggregate amount to not to exceed \$20,000,000; and

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors authorizes the Chief Information Officer or his designee to execute agreements over \$100,000 and in aggregate up to an amount not to exceed \$20,000,000.
