**ACTING AS THE GOVERNING BOARD OF COUNTY SERVICE AREA NO. 8 (NORTH FAIR OAKS), RESOLUTION:**

- A) ADOPTING THE FY 2019-20 GARBAGE AND RECYCLABLES COLLECTION SERVICE CHARGES REPORT FOR COUNTY SERVICE AREA NO. 8 (NORTH FAIR OAKS); AND**
- B) DIRECTING THE DIRECTOR OF OFFICE OF SUSTAINABILITY TO FILE THE FY 2019-20 GARBAGE AND RECYCLABLES COLLECTION SERVICE CHARGES REPORT WITH THE COUNTY CONTROLLER; AND**
- C) AUTHORIZING THE DIRECTOR OF THE OFFICE OF SUSTAINABILITY TO REFUND ANY OVERCHARGES RESULTING FROM DATA, DATA ENTRY OR COMPUTATION ERRORS; AND**
- D) AUTHORIZING THE DIRECTOR OF THE OFFICE OF SUSTAINABILITY TO REVISE THE CHARGES REPORT AS A RESULT OF ANY PARCEL CHANGES RECEIVED FROM THE COUNTY ASSESSOR AND/OR COUNTY CONTROLLER AND TO FILE THE REVISED CHARGES REPORT WITH THE COUNTY CONTROLLER**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, acting as the Governing Board of San Mateo County Service Area No. 8, that

**WHEREAS**, San Mateo County Ordinance Code Sections 4.04.200 through 4.04.330 require that garbage and recyclables collection service charges in County Service Area No. 8 be collected on the tax roll in accordance with the amounts shown for each parcel of real property receiving such service as shown in a written report filed with the Clerk of the Board; and

**WHEREAS**, the Director of the Office of Sustainability of the County of San Mateo has prepared the report described in San Mateo County Ordinance Code Sections 4.04.200 through 4.04.330; and

**WHEREAS**, a public hearing as required by Section 4.04.270 of the San Mateo County Ordinance Code was duly held on July 23, 2019 at 10:15 a.m. in the Board of Supervisors Chambers; and

**WHEREAS**, this Board heard and considered all objections or protests to said report at said public hearing and determined that the garbage and recyclables collection service charges should be confirmed and adopted for the 2019-20 Fiscal Year (FY).

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** as follows:

1. This Board of Supervisors does hereby confirm and adopt said report and imposes the service charges set forth therein to be, and the same are hereby, established and set for FY 2019-20.
2. The Director of the Office of Sustainability is hereby directed to certify to the Clerk of this Board that the service charges are based on the garbage and recyclables collection rates adopted by the Board.
3. The Director of the Office of Sustainability is directed to file with the Controller an electronic copy of said report and a statement endorsed thereon that the service charges as set forth in said electronic copy are the charges as adopted by this Board based on the certification of the Director of the Office of Sustainability.

4. The Director of the Office of Sustainability is authorized to refund, as appropriate, any overcharge contained in said report to the owner of the parcel so overcharged when the overcharge resulted from data, data entry computation errors as determined by the Director of the Office of Sustainability.
5. The Director of the Office of Sustainability is authorized to revise the Charges Report to reflect any parcel changes from the County Assessor and/or County Controller on or after July 17, 2019. Such revisions shall be certified and filed by the Director of the Office of Sustainability with the Controller's Office consistent with the processes set forth above.
