# FIRST AMENDMENT TO AGREEMENT

and KF	RJ DESIGN GROUP, INC., hereinafter called "Contractor";	

#### <u>W I T N E S S E T H</u>:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, on June 29, 2018, the parties entered into an Agreement (the "Agreement") for Contractor to provide design and space planning services to County for the term of July 1, 2018 through June 30, 2021, in an amount not to exceed \$100,000; and

WHEREAS, the parties wish to amend the Agreement to increase its total obligation amount by \$150,000 for a new total obligation amount not to exceed \$250,000 to cover the cost of additional design and consulting services, as may be needed.

# NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

#### 1. Section 3. Payments of the Agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed **TWO HUNDRED AND FIFTY THOUSAND DOLLARS** (\$250,000). In the event that County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by County at the time of contract termination or expiration. Contractor is not entitled to payment for work

not performed as required by this Agreement.

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE
