**RESOLUTION WAIVING THE REQUEST FOR PROPOSAL PROCESS AND  
AUTHORIZING AN AGREEMENT WITH THE REGENTS OF THE UNIVERSITY OF  
CALIFORNIA TO PROVIDE 50% COST SHARE FUNDING WITH THE UNIVERSITY  
OF CALIFORNIA, AGRICULTURE AND NATURAL RESOURCES (UCANR) FOR A  
HUMAN-WILDLIFE INTERACTIONS ADVISOR POSITION, FOR THE TERM OF JULY  
1, 2019 TO JUNE 30, 2022, IN AN AMOUNT NOT TO EXCEED \$216,000**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, Ordinance Code Section 2.83.170 authorizes the Board of Supervisors to waive the Request for Proposals process in any situation where the Board of Supervisors determines that the best interest of the County could be served without the necessity of proposals; and

**WHEREAS**, this Board has been asked to waive the Request for Proposals requirements in order for the University of California Division of Agriculture and Natural Resources to hire a Human-Wildlife Interactions Advisor in consultation and representation by the San Mateo County Agricultural Commissioner.

**WHEREAS**, this Board has determined that it is in the best interest of the County to waive the Request for Proposals process; and

**WHEREAS**, there has been presented to this Board of Supervisors for its consideration and acceptance an Agreement, reference to which is hereby made for further particulars; and

**WHEREAS**, the term of the Agreement is July 1, 2019 through June 30, 2022,  
in an amount not to exceed \$216,000; and

**WHEREAS**, this Board has been presented with the Agreement and has  
examined and approved it as to both form and content and desires to enter into the  
Agreement.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the Board of  
Supervisors requirement for the Request for Proposals process for said Agreement is  
hereby waived.

**BE IT FURTHER RESOLVED**, that the President of the Board of Supervisors be  
and is hereby authorized and directed to execute said Agreement for and on behalf of  
the County of San Mateo, and the Clerk of the Board shall attest to the President's  
signature thereto.

**BE IT FURTHER RESOLVED** that the County Agricultural Commissioner/Sealer is  
hereby authorized to execute amendments to this Agreement which modify the County's  
maximum fiscal obligation by no more than \$25,000 (in aggregate) and/or modify the  
contract term and/or services so long as the modified term or services is/are within the  
current or revised fiscal provisions.
