RESOLUTION AUTHORIZING AN AGREEMENT WITH SONRISAS DENTAL HEALTH, INC. TO PROVIDE DENTAL HEALTH SERVICES FOR THE TERM OF SEPTEMBER 1, 2019 THROUGH AUGUST 31, 2022, FOR AN AMOUNT NOT TO EXCEED \$500,000

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, San Mateo Medical Center (SMMC) provides dental services to the

County's safety net population; and

WHEREAS, some of these individuals have insurance coverage for dental

services through Medicare and Medi-Cal, while others are uninsured; and

WHEREAS, due to a limited number of dentists in the community who accept

Medi-Cal, more patients are seeking dental services at SMMC, resulting in a longer wait times for appointments; and

WHEREAS, Sonrisas Dental Health, Inc. (SDH) currently provides dental care to the County's safety-net patient population in its non-profit, community dental centers through agreements with SMMC's Healthcare for the Homeless/Farmworkers program; and

WHEREAS, Ordinance Code Section 2.83.170 authorizes this Board to waive the RFP process in any situation where the Board of Supervisors determines that the best interest of the County could be served without the necessity of a proposal; and WHEREAS, owing to SDH's familiarity with and experience serving the County's safety net patient population, SMMC is requesting this Board waive the Request for Proposals (RFP) process and approve an agreement, as described below, with SDH to reduce the backlog on its waitlist; and

WHEREAS, this Board has determined it is in the best interest of the County to waive the RFP process; and

WHEREAS, both parties wish to enter an agreement, pursuant to which SDH will provide dental services to patients on SMMC's wait list for the term of September 1, 2019, through August 31, 2022, for an amount not to exceed \$500,000; and

WHEREAS, this Board has been presented with a form of such agreement, has examined and approved it as both form and content, and desires to enter into it.

NOW, THEREFORE, IT IS HEREBY RESOLVED that the RFP process for said agreement is hereby waived.

BE IT FURTHER RESOLVED that the President of the Board of Supervisors be and is hereby authorized and directed to execute said agreement for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Chief of San Mateo County Health or her designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate) and/or modify the

contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
