AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND GRANICUS, LLC.

THIS AMENDMENT TO THE AGREEMENT, entered into this <u>12</u> day of <u>November</u>, 2019, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Granicus, LLC, hereinafter called "Contractor";

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;•

WHEREAS, the parties entered into an Agreement to provide software, hardware, infrastructure, and services for enterprise public meeting systems, including paperless agenda packets, minutes, and streaming video services on December 8, 2016 and

WHEREAS, the parties wish to amend the Agreement to Resolution 074933.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3 of the agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this amendment and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this agreement exceed six hundred and sixty four thousand four hundred and two dollars and seventy five cents (\$664,402.75). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.

2. Section 4 of the agreement is amended in its entirety to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from December 13, 2016 through December 13, 2022.

3. Original Exhibits A and B is amended to add the following services and licenses and amounts payable for the period of December 13, 2019 through December 13, 2022.
