- A) AUTHORIZING THE SHERIFF OR SHERIFF'S DESIGNEE(S) TO SUBMIT A GRANT APPLICATION TO THE STATE OF CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES FOR ADMINISTRATION OF THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY'S HOMELAND SECURITY GRANT PROGRAM AWARD TO ENHANCE THE CAPABILITIES FOR LOCAL FIRST RESPONDERS IN AN AMOUNT NOT TO EXCEED \$2,900,000; AND
- B) AUTHORIZING THE SHERIFF OR SHERIFF'S DESIGNEE(S) TO EXECUTE ON BEHALF OF THE COUNTY OF SAN MATEO ALL NECESSARY APPLICATIONS, CONTRACTS, AGREEMENTS, AMENDMENTS, PAYMENT REQUESTS, AND GRANT ASSURANCES FOR THE PURPOSE OF SECURING AND SPENDING FUNDS THAT MAY BE AWARDED PURSUANT TO THIS GRANT APPLICATION, AND IMPLEMENTING AND CARRYING OUT THE PURPOSES SPECIFIED IN THE GRANT APPLICATION

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, the Sheriff's Office of Emergency Services wishes to apply to the State for grant funding which will enable the local operational area to enhance the ability to plan for, train for, exercise for, and to mitigate and recover from all hazards; and

**WHEREAS**, the Governor's Office of Emergency Services requires the Grantee to certify by resolution that the Governing Body approves of submission of an application to the state; and

**WHEREAS**, the Governor's Office of Emergency Services has received funding allocations for the operational areas to enhance the capabilities of local emergency managers to expand operational readiness, respond to incidents, enhance emergency

planning, training, exercise, preparedness, and improve resiliency in the community;  
and

**WHEREAS;** the San Mateo County Sheriff's Office of Emergency Services will serve as the administrator for the grant award received in the amount NOT TO EXCEED TWO MILLION NINE HUNDRED THOUSAND(\$2,900,000)) by the Governor's Office of Emergency Services to enhance the capabilities of San Mateo County Emergency Management; and ;

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the Board of Supervisors authorizes the Sheriff's or Sheriff's Designee(s) to submit a grant application to the Governor's Office of Emergency Services for administration of the FY 2019 State Homeland Security Grant Program in the amount of \$2,900,000 and execute on behalf of the County of San Mateo all necessary applications, contracts, agreements, amendments, payment request, and grant assurances related thereto for the purposes of securing funds and implement and carry out the purposes specified in the grant application.
