- Paragraph 3. Payments of the Agreement is hereby amended to read as follows:**

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B (revised October 2019). County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this agreement exceed **FIVE HUNDRED EIGHTEEN THOUSAND ONE HUNDRED EIGHTY-FIVE DOLLARS (\$518,185)**. In the event that County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.

3. **Paragraph 4. Term of the Agreement is hereby amended as follows:**
Subject to compliance with all terms and conditions, the term of this Agreement shall be from July 01, 2018 through **June 30, 2021**.
