RESOLUTION 076798 TO DELETE TWELVE POSITIONS, ADD FOURTEEN  
POSITIONS, SET THE SALARY OF TWO CLASSIFICATIONS, AND CONVERT ONE  
UNCLASSIFIED POSITION TO CLASSIFIED.**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

**WHEREAS**, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

**WHEREAS**, San Mateo County Ordinance No. 07303 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

**NOW THEREFORE, IT IS HEREBY ORDERED** that the Board of Supervisors authorizes an amendment to Master Salary Resolution 076798 as follows:

**SECTION 1:** Part 14 of the Resolution is amended as indicated:

ORGANIZATION 12000 COUNTY MANAGER

1. Item E030S, Accountant Series is increased by 1 position for a new total of 3 positions.

#### ORGANIZATION 12600 AGRICULTURAL COMMISSIONER-SEALER

1. Item J070, Pest Detection Supervisor is decreased by 1 position for a new total of 0 positions.
2. Item D131, Program Services Manager I is increased by 1 position for a new total of 1 position.

#### ORGANIZATION 18000 INFORMATION SERVICES DEPARTMENT

1. Item E403, Payroll/Personnel Services Specialist is decreased by 1 position for a new total of 0 positions.
2. Item E029, Administrative Assistant I is increased by 1 position for a new total of 1 position.

#### ORGANIZATION 30000 SHERIFF'S OFFICE

1. Salary for Item D004, Sheriff's Property Manager is set at \$49.34 to \$61.69 per hour.
2. Salary for Item D202, Sheriff's Criminal Records Manager is set at \$51.81 to \$64.76 per hour.

#### ORGANIZATION 32000 PROBATION DEPARTMENT

1. Item E375, Legal Office Specialist is decreased by 9 positions for a new total of 52 positions.
2. Item E020, Pre-Trial Specialist is increased by 9 positions for a new total of 9 positions.

1. Item J083S, Resource Conservation/Sustainability Series is increased by 1 position for a new total of 12 positions.
