**RESOLUTION AUTHORIZING AMENDMENTS TO THE AGREEMENTS WITH THE KPA GROUP AND SMITH-KARNG ARCHITECTURE FOR “ON-CALL” ARCHITECTURAL DESIGN AND CONSULTING SERVICES, INCREASING THE AMOUNT BY \$300,000 PER AGREEMENT FOR A NEW, NOT-TO-EXCEED AMOUNT OF \$600,000 FOR THE KPA GROUP AND \$625,000 FOR SMITH-KARNG ARCHITECTURE, AND EXTENDING THE TERM OF EACH AGREEMENT FOR THREE ADDITIONAL YEARS, TO MARCH 12, 2023**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, on March 14, 2017, this Board of Supervisors did authorize the Department of Public Works to engage the services of professional technical experts; and

**WHEREAS**, under Resolution No. 075083 the County of San Mateo executed agreements with architectural consulting firms: The KPA Group and Smith-Karng Architecture, for \$300,000 per agreement, with each agreement having a three-year term from March 14, 2017 through March 13, 2020; and

**WHEREAS**, on March 19, 2019, the Director of Public Works, and his designee, authorized an Amendment to the Agreement with Smith-Karng Architecture to increase the amount by \$25,000 to \$325,000; and

**WHEREAS**, the public interest and general welfare will be served by extending the terms of the agreements with these qualified architectural consulting firms to continue working on existing on-going project; and

**WHEREAS**, the parties now wish to amend each of the agreements to increase the amount by \$300,000 for a new not-to-exceed amount of \$600,000 for The KPA Group and \$625,000 for Smith-Karng Architecture, and extend the term of each agreement three years, through March 12, 2023; and

**WHEREAS**, the parties will utilize the updated billing rates as presented by the Contractors for the duration of the new term which has been reviewed and approved by the Director of Public Works as within market rates; and

**WHEREAS**, this Board has been presented with the amendments to these respective agreements and has examined and approved them as to both form and content and desires to enter into said amendments.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the Board of Supervisors authorize Amendments to the agreements with The KPA Group and Smith-Karng Architecture, increasing the amount of each agreement by \$300,000 to a new not-to-exceed amount of \$600,000 for The KPA Group and \$625,000 for Smith-Karng Architecture, and extending the term through March 12, 2023 for each agreement, for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

**IT IS FURTHER DETERMINED AND ORDERED** that the Director of Public Works, or designee, is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate) and/or modify the contract term and/or services as long as the modified term or services is/are within the current or revised fiscal provisions.
