

**NINTH AMENDMENT TO
SANITARY SEWAGE TREATMENT CAPACITY RIGHTS
AND SERVICES (THE AGREEMENT)**

This is the Ninth Amendment to the Agreement dated August 7, 2001 by and among the CITY OF REDWOOD CITY (City), the TOWN OF WOODSIDE (Town) and FAIR OAKS SEWER MAINTENANCE DISTRICT (District) collectively the Parties.

RECITALS

- A. The Agreement is intended to govern capacity rights and services for the transmission, treatment and disposal of sewage emanating from the Town's Town Center Sewer Assessment District (TCSAD).
- B. The Agreement indicates in Exhibit A the service area covered by the Agreement (the Service Area).
- C. The Town wishes to amend the Service Area to remove one property at:

155 Bardet Road (APN 073-050-270)
hereinafter, the Property.
- D. The Town Council of the Town has authorized annexation of the Property the District by Resolution 2018-7252 (certified copy attached hereto as Exhibit B).
- E. The Parties desire to amend the Agreement and remove the Property from the Service Area.

THEREFORE, IT IS AGREED:

- 1. The Property is removed from the Service Area and the map being Exhibit A to the Agreement is amended accordingly.
- 2. Sewer service shall be provided to the Property by the District.

EXHIBIT "A" - TOWN CENTER SEWER ASSESSMENT DISTRICT







RESOLUTION NO. 2018-7252

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF WOODSIDE
CONSENTING TO THE REMOVAL OF 155 BARDET FROM THE TOWN CENTER SEWER
ASSESSMENT DISTRICT AND ANNEXATION TO THE FAIR OAKS SEWER MAINTENANCE
DISTRICT (APN 073-050-270)**

WHEREAS, the property at 155 Bardet, APN 073-050-270, lies within the boundaries of the Redwood Creek Trunk Sewer Assessment District and was initially assessed a sewer connection to the Redwood Creek Sewer Assessment District (RCSAD) owned and operated by Fair Oaks Sewer Maintenance District (FOSMD). The parcel was also subsequently included in the Town Center Sewer Assessment District (TCSAD); and

WHEREAS, the property constructed a new gravity sewer lateral connecting to FOSMD in the early 1990s, however FOSMD has no record of the connection; and

WHEREAS, the property residence is currently being reconstructed and the property owner has requested that the existing sewer connection be allowed to remain; and

WHEREAS, because the existing connection drains by gravity to FOSMD and would need to be pumped if it were connected to the TCSAD system, Town and FOSMD staff agree it would be appropriate to formally annex the property to FOSMD and remove the property from the TCSAD; and

WHEREAS, this Council finds that such annexation would be in the best interest of the Town and of the Fair Oaks Sewer Maintenance District, according to the agreement between the two agencies, dated April 2, 1968.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF WOODSIDE that the Town of Woodside hereby removes that certain real property situated in the Town of Woodside, County of San Mateo, State of California, identified as Assessor's Parcel Number 073-050-270 from the Town Center Sewer Assessment District and consents to the annexation of all of that certain real property situated in the Town of Woodside, County of San Mateo, State of California, identified as Assessor's Parcel Number 073-050-270 to the Fair Oaks Sewer Maintenance District.


