## AMENDMENT THREE TO THE AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND STARVISTA

THIS AMENDMENT TO THE AGREEMENT, entered into this day of
, 20, by and between the COUNTY OF SAN MATEO, hereinafter
called "County," and StarVista, hereinafter called "Contractor";

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;
WHEREAS, on December 5, 2017, the parties entered into an Agreement to provide services in San Mateo's North, Central, and Coastal Regions for a total amount of \$846,907 for the term of December 6, 2017 through December 5, 2018. This agreement was subsequently amended on December 4, 2018 and on December 4, 2019, to include the Southern Region and add additional funding for a revised total amount of \$2,000,314 and a revised term of December 6, 2017 through December 5, 2020; and
WHEREAS, the parties wish to amend the Agreement to add funding in the amount of \$1,253,407 for a revised total of \$3,253,721.
NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:
1. Paragraph 1 Exhibits, is amended to read as follows:
The following exhibits and attachments are attached to this Agreement and incorporated into this Agreement by this reference:
Exhibit A – Services Exhibit B – Outcomes and Reporting Requirements Exhibit C – Payment Schedule (Revised 12/2018) Exhibit C1 – Budgets (Revised 12/2019) Exhibit D – Child Abuse Prevention and Reporting Attachment A – Fingerprinting Certification Attachment I - § 504 Compliance Attachment P – Personally Identifiable Information

2. Paragraph 2 Services to be performed by the Contractor, is amended to read as follows:

In consideration of the payments set forth in this Agreement, Exhibit C (Revised 12/2018), and Exhibit C1 (Revised 12/2019), Contractor shall perform services for County in accordance with the terms, conditions, and specifications set forth in this Agreement and in Exhibit A.

## 3. Paragraph 3 Payments, is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibits A and B (Revised 12/2019), County shall make payments to Contractor based on the rates and in the manner specified in Exhibits C and C1 (Revised 12/2019). County reserves the right to withhold payments if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed **THREE MILLION**, **TWO HUNDRED FIFTY-THREE THOUSAND**, **SEVEN HUNDRED AND TWENTY-ONE DOLLARS** (3,253,721). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this Agreement.

## 4. Exhibit B - Program Monitoring and Outcomes is amended as follows:

All instances of "FY 2018-19 Target" is replaced with "FY 2019-20 Target" and all instances of "FY 2019-20\* Target" is replaced with "FY 2020-21\* Target". Performance table footnote is amended to read: \*Measure tracks services for 5 months from July 1, 2020 to December 5, 2020.

- 5. Exhibit C (Revised 12/2018), Method and Rate of Payment, subsection K is removed in its entirety.
- 6. Exhibit C1 Budget (Revised 12/2019) hereby replaces Exhibit C1 Budget (Revised 12/2018) in its entirety and is attached hereto.
- 7. All other terms and conditions of the Agreement dated December 5, 2017, between the County and Contractor shall remain in full force and effect.
