

AMENDMENT TO AGREEMENT
BETWEEN THE COUNTY OF SAN MATEO AND WOODSIDE FIRE PROTECTION
DISTRICT

THIS AMENDMENT TO THE AGREEMENT, entered into this 25 day of July, 2017,
by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Woodside
Fire Protection District, hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with
independent contractors for the furnishing of such services to or for County or any Department
thereof;

WHEREAS, the parties entered into an Agreement for Woodside Fire District contract
for Los Trancos Woods -Fire Safety services on July 25, 2017; and

WHEREAS, the parties wish to amend the Agreement to Woodside Fire Protection
District - Contract.

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS
FOLLOWS:**

1. Section 3 of the agreement is amended to read as follows:

Payments

- 1) In consideration of the services provided by Contractor in accordance with all terms,
conditions, and specifications set forth in this Agreement and in Exhibit A; Part 1,
County shall make payment to Contractor based on the rates and in the manner
specified in Exhibit A: Part 2. County reserves the right to withhold payment if

County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed Four Hundred and Seventy-Four Thousand and Five Hundred Dollars, (\$474,500).

In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration.

Electronic Record and Signature Disclosure

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carasoft OBO County of San Mateo (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies

Withdrawing your consent
