RESOLUTION: A) ADOPTING PLANS AND SPECIFICATIONS, INCLUDING CONFORMANCE WITH PREVAILING WAGE SCALE REQUIREMENTS FOR THE SAN CARLOS AIRPORT RUNWAY AND TAXIWAYS PAVEMENT REHABILITATION PROJECT; AND B) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO CALL FOR SEALED PROPOSALS TO BE RECEIVED BY TUESDAY, MAY 11, 2020 AT 2:30 P.M., IN THE OFFICE OF THE CLERK OF THE BOARD OF SUPERVISORS; AND, C) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO EXTEND THE CALL FOR BID AND BID OPENING UP TO 60 DAYS BEYOND THE TIME AND DATE ORIGINALLY SET FORTH BY THE BOARD OF SUPERVISORS; AND, D) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO EXECUTE FEDERAL AVIATION ADMINISTRATION AND CALIFORNIA DEPARTMENT OF TRANSPORTATION GRANTS FOR THE SAN CARLOS AIRPORT RUNWAY AND TAXIWAYS PAVEMENT REHABILITATION PROJECT

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, plans and specifications have been reviewed and approved by the Director of Public Works for the San Carlos Airport Runway and Taxiways Pavement Rehabilitation Project and said plans and specifications have been filed in the office of the Director of Public Works; and

WHEREAS, the plans and specifications require that the contractors performing the work pay not less than the general prevailing rates of wages, as established by the Department of Industrial Relations, in the locality in which said work is to be performed for each type of workman needed to execute the contract.

WHEREAS, the Director of Public Works executed a Federal Aviation Administration (FAA) grant to design the San Carlos Airport Runway Pavement Rehabilitation Project (Rehabilitation Project). The Rehabilitation Project has been designed in accordance with FAA guidelines and has been reviewed and approved by the FAA.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that:

1. The plans and specifications dated February 2020, for the aforesaid project, which are on file in the office of the Director of Public Works, are hereby approved and adopted as the plans and specifications to be adhered to in letting and performing the work under a contract for said improvements.
2. Said specifications require that the contractors performing the work pay not less than the general prevailing rates of wages, as established by the Department of Industrial Relations, in the locality in which said work is to be performed for each type of workman needed to execute the contract.
3. The Department of Public Works is authorized and directed to issue a call for sealed bids and the Director of Public Works is authorized to call for bids and to set the bid opening date and time on or before Tuesday, May 11, 2020 at 2:30 p.m. in said office of the Clerk of the Board of Supervisors.

4. The Director of Public Works is authorized to extend the call for bid and bid opening up to 60 days beyond the time and date originally set forth by the Board of Supervisors.

5. The Director of Public Works is authorized to execute grants from the Federal Aviation Administration and California Department of Transportation for the construction of the San Carlos Airport Runway Pavement Rehabilitation Project.
