RESOLUTION CERTIFYING THE MILEAGE IN THE COUNTY OF SAN MATEO'S MAINTAINED ROAD SYSTEM TO BE 316.157 MILES AS OF DECEMBER 31, 2019

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Section 2121 of the California Streets and Highway Code provides

that each year counties shall submit to the California Department of Transportation the

additions to and deletions from their total mileage of maintained county roads; and

WHEREAS, the California Department of Transportation certified to the State

Controller that the total mileage of County-maintained roads in the County of San

Mateo, as of December 31, 2018 was 316.228 miles; and

WHEREAS, the Director of Public Works has reported that as of December 31, 2019, there was a 0.275-mile increase and a 0.346-mile decrease or a 0.071-mile net decrease to the total mileage of maintained County roads; and

WHEREAS, the Director of Public Works has also reported that as of December 31, 2019, the total mileage of maintained County roads is 316.157 miles.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED based on the information provided by the Director of Public Works, that this Board certifies the

County maintained mileage as described in Exhibit "A", "Summary of County of San Mateo Maintained Road Mileage as of December 31, 2019" attached hereto and made a part hereof, which indicates that the mileage of County of San Mateo-maintained roads as of December 31, 2019 is 316.157 miles.

0.275 Additions and 0.346 Deletions to Maintained Road Mileage in 2019

- 1. CANYON ROAD, (County Road Number 388), Emerald Lake Hills Area, from Cordilleras Road (County Road Number 25) to County Boundary on Canyon Road, was re-logged. The County maintained mileage has increased 268.32 feet or 0.0508 centerline miles, which reflects the re-logging. Total maintained mileage for the specified section of road is 532.32 feet or 0.101 centerline miles.
- 2. FIFTH AVENUE (North Frontage Road), (County Road Number 23), North Fair Oaks Area, from Glendale Avenue (County Road Number 342) to Waverly Avenue (County Road Number 340) was added to the County maintained network.

FIFTH AVENUE (South Frontage Road), (County Road Number 23), North Fair Oaks Area, from Glendale Avenue (County Road Number 342) to Fifth Avenue (County Road Number 23) was added to the County maintained network. Both road segments were constructed as part of the Fifth Avenue and railroad grade separation project but were not previously added to the road mileage inventory. The County maintained mileage has increased 987.36 feet or 0.187 centerline miles. Total maintained mileage for the specified section of road is or 6,269.36 feet or 1.187 centerline miles.

- 3. GLENDALE AVENUE, (County Road Number 342), North Fair Oaks Avenue, from Fifth Avenue (South Frontage Road) (County Road Number 23) to Fifth Avenue (North Frontage Road) (County Road Number 23) was added to the County maintained network as part of the Fifth Avenue and railroad grade separation project but were not previously added to the road mileage inventory. The County maintained mileage has increased 195.36 feet or 0.037 centerline miles. Total maintained mileage for the specified section of road is 2,254.36 feet or 0.427 centerline miles.
- 4. MIRADA ROAD, (1/2 STREET) (County Road Number 99-B), El Granada Area, from Cabrillo Highway (Highway 1) to End of Road was deleted from the County maintained network. The road has become a bike trail and is now maintained by the County Parks Department. The County maintained mileage has decreased 264.00 feet or 0.050 centerline miles. Total maintained mileage for the specified section of road is 0.00 feet or 0.000 centerline miles.

5. O'NEILL AVENUE (1/2 STREET), (County Road Number 400),

Harbor/Industrial Area of Belmont from Elmer Street (County Road Number 417) to County Boundary 25-feet west of Granada Street right of way and County Boundary 25-feet east of Granada Street right of way to County boundary before Dairy Road/Karen Road was annexed to the City of Belmont by LAFCo File 17-19 Resolution 2020-001665 CONF. The County maintained mileage has been decreased by 1,437.00 feet or 0.272 centerline miles, which reflects the annexation to the City of Belmont. Total maintained mileage for the specified section of road is 0.00 feet or 0.000 centerline miles.

- 6. OLD COUNTY ROAD, (County Road Number 21), Harbor/Industrial Area of Belmont from the northern right of way limit of Karen Road/alley with Old County Road along Old County Road in the northern direction a distance of 125.78-feet was annexed to the City of Belmont by LAFCo File 17-19 Resolution 2020-001665 CONF. The County maintained mileage has been decreased by 125.78 feet or 0.024 centerline miles, which reflects the annexation to the City of Belmont. Total maintained mileage for the specified section of road is 930.23 feet or 0.176 centerline miles.
