RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH HEALTHRIGHT360 FOR SUBSTANCE USE DISORDER TREATMENT SERVICES, MEDICATION ASSISTED TREATMENT SERVICES, OUTPATIENT MENTAL HEALTH SERVICES, AND OUTREACH AND ENGAGEMENT SERVICES, AND EXTENDING THE TERM OF SUBSTANCE USE DISORDER PREVENTION SERVICES THROUGH JUNE 30, 2021, INCREASING THE AMOUNT OF THE AGREEMENT BY \$143,412 TO AN AMOUNT NOT TO EXCEED \$10,679,744

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on July 23, 2019, the Board approved an agreement with HealthRIGHT 360 (HR360) to provide substance use disorder prevention and treatment services, medication assisted treatment services, outpatient mental health services, and outreach and engagement services, for the term July 1, 2019 through June 30, 2021, in an amount not to exceed \$9,993,072; and

WHEREAS, on December 3, 2019, the Board approved an amendment to the agreement whereby HR360: 1) received a Cost of Living Adjustment for substance use disorder prevention and treatment services, mental health services, and outreach and engagement services, and 2) removed Parent Project curriculum, increasing the maximum obligation of the agreement by \$543,261 to an amount not to exceed \$10,536,333; and

WHEREAS, there has been presented to the Board of Supervisors for its consideration and acceptance an amendment to the agreement, reference to which is hereby made for further particulars, whereby HR360 shall provide additional prevention

activities in FY 2019-20, add prevention activities in FY 2020-21, extending the term of the agreement through June 30, 2021, and increasing the maximum amount by \$143,412 to an amount not to exceed \$10,679,744; and

WHEREAS, the Board has been presented with the amendment and has examined and approved it as to both form and content and desires to enter into the amended agreement.

BE IT FURTHER RESOLVED that the President of this Board of Supervisors is hereby authorized and directed to execute said agreement for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Chief of San Mateo County Health or designee is hereby authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
