WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for a SharePoint and Office 365 administration, management, and reporting Software as a Service solution on March 30, 2018; and

WHEREAS, the parties wish to amend the Agreement to continue the Microsoft Software as a Service solution and to provide administration, management, and reporting services for the County's SharePoint and Office 365 environment.

## NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3. Payments of the agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed One Hundred Forty-Eight Thousand, Five Hundred dollars (\$148,500.00). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.

**2.** Section 4. Term of the agreement is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from March 30, 2018 through March 29, 2021.

**3.** Original Exhibit B is replaced with Revised Exhibit B (rev. [03/12/2020]).

In consideration of the services provided by Contractor described in Exhibit A and subject to the terms of the Agreement, County shall pay Contractor based on the following fee schedule and terms:

The total not to exceed amount for this Agreement is \$148,500.

Should the County wish to continue the services and support provided by Contractor, an Amendment to this Agreement will be executed.

## **Invoicing Procedures**

County shall pay Contractor, upon receipt of an invoice, for services rendered. Each invoice submitted must include the following information, at a minimum:

- 1. Agreement number/PO number
- 2. Time period covered
- 3. Detailed statement of services/work completed for the invoice period
- 4. Breakdown of labor, materials and taxes

Payments shall be made within Net 30 days from the date of the applicable undisputed invoice.

4. All other terms and conditions of the agreement dated March 30, 2018, between the County and Contractor shall remain in full force and effect.
