AMENDMENT TWO TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND TURBO DATA SYSTEMS, INC.

THIS AMENDMENT TWO TO THE AGREEMENT, entered into this 5th day of May 2020, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and TURBO DATA SYSTEMS, INC., hereinafter called "Contractor";

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for parking citation processing and adjudication services on May 19, 2015; and

WHEREAS, in May 2019, Amendment One was approved which increased the amount of the Agreement; and

WHEREAS, the parties wish to further amend the Agreement to increase the amount by \$140,000 to an amount not to exceed \$490,000 and extend the term of the Agreement to June 30, 2021.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3, Payments, of the agreement is amended to read as follows:

3. Payments

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed **FOUR HUNDRED NINETY THOUSAND DOLLARS AND ZERO CENTS** (\$490,000). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration.

2. Section 4, Term, of the agreement is amended to read as follows:

4. Term

Subject to compliance with all terms and conditions, the term of this Agreement shall be from May 19, 2015 through June 30, 2021.

3. All other terms and conditions of the agreement dated May 19, 2015 and Amendment One dated May 14, 2019 between the County and Contractor, which are not in conflict, shall remain in full force and effect.
