**RESOLUTION AUTHORIZING THE PRESIDENT OF THE BOARD OF SUPERVISORS TO EXECUTE AGREEMENTS THROUGH THE YOUTH OFFENDER BLOCK GRANT (YOBG): A) AN AGREEMENT WITH THE ART OF YOGA PROJECT TO CONTINUE TO PROVIDE YOGA AND CREATIVE ARTS CURRICULUM TO YOUTH AT MARGARET J. KEMP CAMP, YOUTH SERVICES CENTER, AND YOUTH ENROLLED IN REENTRY PROGRAMS FOR THE TERM OF JULY 1, 2020, THROUGH JUNE 30, 2023, IN AN AMOUNT NOT TO EXCEED \$169,950.00; AND B) AN AGREEMENT WITH FRESH LIFELINES FOR YOUTH, INC. TO CONTINUE TO PROVIDE LAW EDUCATION CLASSES AND CASE MANAGEMENT TO YOUTH AT MARGARET J. KEMP CAMP, YOUTH SERVICES CENTER, AND YOUTH ENROLLED IN REENTRY PROGRAMS FOR THE TERM OF JULY 1, 2020, THROUGH JUNE 30, 2023, IN AN AMOUNT NOT TO EXCEED \$647,374.20; AND C) AN AGREEMENT WITH STARVISTA TO CONTINUE TO PROVIDE INDIVIDUAL AND GROUP THERAPY AS WELL AS ALCOHOL AND DRUG COUNSELING AT MARGARET J. KEMP CAMP, YOUTH SERVICES CENTER, AND YOUTH ENROLLED IN REENTRY PROGRAMS FOR THE TERM OF JULY 1, 2020, THROUGH JUNE 30, 2023, IN AN AMOUNT NOT TO EXCEED \$405,385.20; AND D) AN AGREEMENT WITH RAPE TRAUMA SERVICES TO CONTINUE TO PROVIDE CRISIS INTERVENTION, MINDFULNESS GROUPS, AND VIOLENCE PREVENTION EDUCATION SESSIONS TO YOUTH AT MARGARET J. KEMP CAMP, YOUTH SERVICES CENTER, AND YOUTH ENROLLED IN REENTRY PROGRAMS FOR THE TERM OF JULY 1, 2020, THROUGH JUNE 30, 2023, IN AN AMOUNT NOT TO EXCEED \$123,986.50.**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, in January 2020, the Probation Department completed a Request for Proposals (RFP) process to establish contracts for youth activities and mental health services funded through the Youth Offender Block Grant (YOBG); and

**WHEREAS**, The Art of Yoga Project, Fresh Lifelines for Youth, Inc., StarVista,

and Rape Trauma Services have been selected through the RFP process to provide services to juvenile justice-involved youth; and

**WHEREAS**, the Probation Department and The Art of Yoga Project wish to enter into an Agreement to provide yoga and creative arts curriculum to youth at the Youth Services Center and Margaret J. Kemp Camp for a term of July 1, 2020, through June 30, 2023, in an amount not to exceed \$169,950.00 and;

**WHEREAS**, the Probation Department and Fresh Lifelines for Youth, Inc. wish to enter into an Agreement to provide law education classes to educate youth about the law and their rights and foster healthy attitudes about crime, illegal activity and risky behavior while building life skills that will increase their capacity to problem-solve in pro-social ways for a term of July 1, 2020, through June 30, 2023, in an amount not to exceed \$647,374.20; and

**WHEREAS**, the Probation Department and StarVista wish to enter into an Agreement to provide individual and group therapy clinicians responsible for providing a therapeutic safe space for the youth by using evidence-based curriculums such as trauma-informed Cognitive Behavioral Therapy (CBT) and Dialectical Behavior Therapy (DBT) for a term of July 1, 2020, through June 30, 2023, in an amount not to exceed \$405,385.20 and;

**WHEREAS**, the Probation Department and Rape Trauma Services wish to enter into an Agreement to provide crisis intervention, mindfulness groups, and violence prevention education sessions at the Youth Services Center and Margaret J. Kemp Camp to support youth recovering from core relationship trauma such as sexual abuse or assault and domestic violence for a term of July 1, 2020, through June 30, 2023, in

an amount not to exceed \$123,986.50 and;

**WHEREAS**, the Board has been presented with this Agreement and has approved it as to both form and content and desires to enter into the Agreement.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the President of the Board is hereby authorized and directed to execute said Agreements for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED** that the Chief Probation Officer or his designee is authorized to execute contract amendments that modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate) for each said Agreement, and/or modify the contract term and/or services so long as he modified term of services is/are within the current or revised fiscal provisions.
