**RESOLUTION AUTHORIZING THE DIRECTOR OF THE PROJECT DEVELOPMENT UNIT, OR DESIGNEE, TO EXECUTE PURCHASE ORDERS WITH VWR INTERNATIONAL, LLC TO PROCURE, FURNISH AND INSTALL FURNITURE, LABORATORY EQUIPMENT, AND SUPPLIES FOR THE SAN MATEO HEALTH CAMPUS PROJECT IN AN AMOUNT NOT TO EXCEED \$220,000**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, in March 2017, this Board approved the San Mateo Health Campus Project which includes renovation of the nursing wing ground floor and central plant to relocate essential services, demolition of campus administration buildings built in 1954, and construction of a new administration building; and

**WHEREAS**, the County of San Mateo Health Campus uses VWR International, LLC (VWR) as the Public Health Laboratory vendor for lab furnishings, equipment, and supplies; and

**WHEREAS**, new furniture and equipment for the new Public Health Laboratory will be ordered, in addition to reusing the existing lab furnishing and equipment previously provided by VWR; and

**WHEREAS**, VWR is a market leading vendor for lab furnishings, equipment, and supplies and the County will obtain discounted rates as agreed upon by the Master Agreement, and substantial cost savings by reusing existing furnishings rather than purchasing all new equipment; and

**WHEREAS**, NASPO ValuePoint, the cooperative arm of the National Association of State Procurement Officials (NASPO), awarded VWR a competitively solicited

cooperative purchasing agreement under Master Agreement No. MA16000234-2 and this, and similar competitively solicited agreements that may be relied upon by the County, provide pricing on a variety of laboratory furnishings, equipment, and supplies that has been assessed to be fair, reasonable, and competitive; and

**WHEREAS**, the Project Development Unit recommends that it is in the best interest of the County to enter into purchase orders and other necessary agreements with VWR for the purchase of laboratory furnishings, equipment, and supplies for the San Mateo Health Campus project.

**WHEREAS**, County Counsel has reviewed and approved the resolution as to form.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the President of the Board of Supervisors shall adopt a resolution authorizing the Director of the Project Development Unit, or designee, to execute purchase orders and other necessary agreements with VWR International, LLC to procure, furnish and install furniture, laboratory equipment, and supplies and to provide additional services for the San Mateo Health Campus Project in an amount not to exceed \$220,000.

**BE IT FURTHER RESOLVED** that the Director of the Project Development Unit, or designee, is authorized to execute contract amendments and other modifications to the terms, conditions, and/or services, including but not limited to modifications to the County's maximum fiscal obligation by no more than \$25,000 (in aggregate) and term, so long as the modified term or services is/are within the current or revised fiscal provisions.
