

**AMENDMENT ONE TO THE AGREEMENT R075495A BETWEEN THE COUNTY OF
SAN MATEO AND FAITHFUL+GOULD, INC.**

THIS AMENDMENT TO THE AGREEMENT, entered into this 29th day of September 2020, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Faithful+Gould, Inc., hereinafter called "Contractor", (collectively the "Parties");

WITNESSETH:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of services to or for County or any Department thereof;

WHEREAS, on October 17, 2017 the Parties entered into an Agreement for On Call Professional Services to provide cost management and construction estimating services;

WHEREAS, the Parties wish to amend the Agreement to modify the term of the agreement;

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS
FOLLOWS:**

1. Section 4 "Term", of the Agreement dated October 17, 2017 is hereby deleted in its entirety and replaced with:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from October 17, 2017 through October 16, 2022.

2. Section 17 "Notices", of the Agreement dated October 17, 2017 is hereby deleted in its entirety and replaced with:

Any notice, request, demand, or other communication required or permitted under this Agreement shall be deemed to be properly given when both: (1) transmitted via facsimile to the telephone number listed below or transmitted via email to the email address listed below; and (2) sent to the physical address listed below by either being deposited in the United States mail, postage prepaid, or deposited for overnight delivery, charges prepaid, with an established overnight courier that provides a tracking number showing confirmation of receipt.


