RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH SIEMENS MEDICAL SOLUTIONS USA, INC. TO CONTINUE SUPPORT OF THE RADIOLOGY INFORMATION SYSTEM ALSO KNOWN AS SYNGO WORKFLOW, EXTENDING THE TERM OF THE AGREEMENT BY THREE YEARS THROUGH DECEMBER 31, 2023 AND INCREASING THE AMOUNT BY \$205,000 TO AN AMOUNT NOT TO EXCEED \$505,000

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on January 23, 2018, this Board approved an agreement to maintain and upgrade Siemens Radiology Information System (RIS) also known as syngo Workflow, at the San Mateo Medical Center (SMMC); and

WHEREAS, on May 15, 2018, the agreement was amended to correct the amount of the Sybase fee to be deleted when the upgrade is completed and extend the timing of second upgrade payment; and

WHEREAS, an extension of the current agreement by three years, from December 21, 2020 to December 31, 2023 is necessary to continue the utilization of syngo Workflow services at SMMC and increase the County's total fiscal obligation by \$205,000 for a new total fiscal obligation of \$505,000; and

WHEREAS, County Health is requesting your Board waive the Request for Proposals (RFP) process to allow Siemens to continue to provide these services and

increase the funding through the end of the extended term. while County Health evaluates options for a Health System Electronic Health Record; and

WHEREAS, SMMC will also be replacing the current servers on which syngo Workflow resides; and

WHEREAS, Ordinance Code Section 2.83.170 authorizes the Board of Supervisors to waive the RFP process in any situation where the Board of Supervisors determines that the best interest of the County could be served without the necessity of a proposal; and

WHEREAS, this Board has determined it is in the best interest of the County to waive the RFP process; and

WHEREAS, this Board has been presented with a form of the amendment, has examined and approved it as to both form and content, and desires to enter into the amendment; and

BE IT FURTHER RESOLVED, that the President of this Board of Supervisors be and is hereby authorized and directed to execute said amendment for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED, that the Chief of San Mateo County Health or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the

contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
