AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND RAVENSWOOD FAMILY HEALTH CENTER

	THIS AMENDMENT TO THE AGREEMENT, entered into this _	day of
	, 2020, by and between the COUNTY OF SAN MATEO	D, hereinafter called
"Coun	ty," and Ravenswood Family Health Center, hereinafter called "Con	tractor":

<u>WITNESSETH:</u>

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for primary care services on February 13, 2018, for the term of January 1, 2018, through December 31, 2020, in an amount not to exceed \$321,300; and

WHEREAS, the parties wish to amend the Agreement to extend the term of the Agreement by 6 months through June 30, 2021, and increase the maximum payable by \$33,057, to an amount not to exceed \$354,357.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3. Payments of the Agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed THREE HUNDRED FIFTY-FOUR THOUSAND THREE HUNDRED FIFTY-SEVEN DOLLARS (\$354,357). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this Agreement. All invoices must be approved by the Health Care for the Homeless Program Manager or their designee and paid within 30 days of receipt of the invoice. Invoices must be sent to: SMMC-Accounts-Payable@smcgov.org. Processing time may be delayed if invoices are not submitted electronically.

- 2. Section 4, Terms of the Agreement is amended to read as follows:
 - Subject to compliance with all terms and conditions, the term of this Agreement shall be from January 1, 2018, through June 30, 2021.
- 3. Original Exhibit A and Exhibit B are hereby replaced in their entirety with Revised Exhibit A, (rev. 8/20/20) and Revised Exhibit B (rev. 8/20/20) respectively, copies of which are attached hereto and incorporated into the Agreement by this reference.
- 4. All other terms and conditions of the Agreement dated February 13, 2018, between the County and Contractor shall remain in full force and effect.
