RESOLUTION AUTHORIZING THE PRESIDENT OF THE BOARD TO EXECUTE AN AMENDMENT TO THE AGREEMENT WITH CORINTHIAN INTERNATIONAL PARKING SERVICES INCREASING THE COUNTY'S MAXIMUM FISCAL OBLIGATION BY \$1,461,381 FOR SHUTTLE SERVICES AT THE CORDILLERAS PROJECT SITE.

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Cordilleras Health Campus Replacement (Cordilleras) Project,

located at the 200 Edmonds Road in Redwood City, has been authorized by this Board

and construction Notice to Proceed was issued November 18, 2020; and

WHEREAS, the Project Development Unit (PDU) has identified a critical need for

off-site staff parking which requires a shuttle service to transport County and end-user

staff persons from the parking area to the mental health facility throughout the duration

of construction; and

WHEREAS, the PDU conducted a Request for Proposals selection process to

ensure the County receives the best value for this shuttle service scope of work; and

WHEREAS, Corinthian's proposal was selected for the best value and best price;

and

WHEREAS, this Board adopted resolution R076192 on October 2, 2018 approving a prior agreement with Corinthian for the assisted stack parking and shuttle services required to support the San Mateo Health Campus project, and WHEREAS, Agreement R076192 has been expanded in scope by this Board through the adoption of resolution R076527 which added parking services at the Government Center parking garage, Amendments Two and Three approved by the PDU to add security scope of work at Sequoia Station jury parking, and resolution R077152 which increased the contract amount; and

WHEREAS, effort to consolidate parking services into a single agreement, the PDU has opted to incorporate this Cordilleras shuttle scope of work into the existing Agreement R076192 through the approval of the proposed Amendment Five; and

WHEREAS, on January 7, 2020, this Board adopted resolution 077152 increasing the contract value for the Government Center assisted stack parking and security services; and

WHEREAS, both parties wish to amend the agreement between the County and Corinthian to add shuttle service operations in support of the Cordilleras Project as proposed; and

WHEREAS, this Board has approved the amendments to the agreement as to both form and content and desires to enter into the amended agreement; and

WHEREAS, County Counsel has reviewed and approved the Resolution as to form;

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

President of the Board to execute an amendment to the agreement with Corinthian International Parking Services increasing the County's maximum fiscal obligation by \$1,461,381 and modifying the scope of services to include shuttle service operations for the Cordilleras Project.

BE IT FURTHER RESOLVED that the Director of the Project Development Unit or designee is authorized to execute additional contract amendments which modify the County's fiscal obligation by no more than \$25,000 (in aggregate) and/or modify the contract terms or services so long as the modified terms or services is/are within the current or revised fiscal provisions.
