AMENDMENT TWO TO AGREEMENT

BETWEEN THE COUNTY OF SAN MATEO AND THYSSENKRUPP ELEVATOR CORPORATION

THIS AMENDMENT TO THE AGREEMENT, entered into this ____ day of

_____, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and THYSSENKRUPP ELEVATOR CORPORATION, hereinafter called "Contractor";

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, on March 27, 2018 the parties entered into an Agreement under Resolution No. 075810 for professional elevator maintenance services; and,

WHEREAS, on November 18, 2020, under Amendment No. One amended the Agreement with Thyssen Krupp to utilize \$200,000 contingency funds stated in the original agreement; and

WHEREAS, the parties wish to amend the Agreement and add an additional One Hundred and Fifty Thousand Dollars (\$150,000). The term will remain from April 1, 2018 to March 31, 2021.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 6 (Payments) of the agreement is amended under Amendment No. Two to add an additional One Hundred and Fifty Thousand Dollars (\$150,000) to the agreement to read as follows:

In no event shall County's total fiscal obligation under this agreement exceed One Million, Three Hundred and Four Thousand (\$1,304,000).

2. All other terms and conditions of the agreement dated March 27, 2018, between the County and Contractor shall remain in full force and effect.

Electronic Record and Signature Disclosure

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE
