AMENDMENT TO AGREEMENT

BETWEEN THE COUNTY OF SAN MATEO AND CSG CONSULTANTS, INC.

THIS AMENDMENT TO THE AGREEMENT, entered into this 13 day of November, 2018, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and CSG Consultants, Inc., hereinafter called "Contractor";

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for Amendment 1 to CSG Consultants, Inc. Agreement -A1 services on January 5, 2021; and

WHEREAS, the parties wish to amend the Agreement to CSG Consultants, Inc - Contract.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3 "Payment", of the Agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal

obligation under this Agreement exceed One Million Dollars (\$1,000,000). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.

- 2. The not-to-exceed amount as stated in Exhibit "B" of the original Agreement shall be amended to be \$1,000,000.
- **3.** All other terms and conditions of the agreement dated November 13, 2018, between the County and Contractor shall remain in full force and effect.
