RESOLUTION: A) ADOPTING PLANS AND SPECIFICATIONS, INCLUDING CONFORMANCE WITH FEDERAL PREVAILING WAGE SCALE REQUIREMENTS, FOR THE COUNTYWIDE PAVEMENT MAINTENANCE PROJECT; AND B) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO CALL FOR SEALED PROPOSALS TO BE RECEIVED BY WEDNESDAY, MARCH 24, 2021 AT 2:30 P.M. IN THE OFFICE OF THE COUNTY MANAGER/CLERK OF THE BOARD OF SUPERVISORS; AND C) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO EXTEND THE CALL FOR BIDS AND BID OPENING UP TO SIXTY (60) CALENDAR DAYS BEYOND THE TIME AND DATE ORIGINALLY SET FORTH BY THE BOARD OF SUPERVISORS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on January 10, 2017, this Board adopted Resolution No. 074983, which authorized the Director of Public Works, or designee, to file an application for funding from the Metropolitan Transportation Commission, committing any necessary matching funds, and stating assurance to complete the Countywide Pavement Maintenance (formerly titled "San Mateo Countywide Cape Seal Project"); and

WHEREAS, plans and specifications dated November 24, 2020 have been prepared and approved by the Director of Public Works for the Countywide Pavement Maintenance Project, and said plans and specifications have been filed in the office of the Director of Public Works (the "plans and specifications"); and

WHEREAS, the plans and specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by

the Department of Labor on federally funded projects, in the locality in which said work is to be performed for each type of workman needed to execute the contract.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

- 1. The plans and specifications dated November 24, 2020, for the aforesaid project, which are on file in the office of the Director of Public Works, and to which reference is hereby made for further particulars, are hereby approved and adopted as the plans and specifications to be adhered to in letting and performing the work under a contract for the improvements described therein.
- 2. Said specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by the Department of Labor on federally funded projects, in the locality in which said work is to be performed for each type of workman needed to execute the contract.
- 3. The Department of Public Works is authorized and directed to issue a call for sealed bids and to set the bid opening date and time on Wednesday, March 24, 2021 at 2:30 p.m. Said bids will be received by the Clerk of the Board of Supervisors in the Hall of Justice, Redwood City, California. Due to the COVID-19 pandemic and Governor's shelter-in-place order, bids will be publicly opened and declared outside of the public entrance located on the north side of the Hall of Justice building, Redwood City, California.

- 4. The Director of Public Works is authorized to extend the call for bids and bid opening up to sixty (60) calendar days beyond the time and date originally set forth by the Board of Supervisors.
- 5. The Department of Public Works is further directed to cause the Notice inviting sealed bids to be published for three (3) times in a weekly local newspaper of general circulation, published in the County, and obtain an affidavit of said publication, a copy of which shall be placed on file with the Department of Public Works.
