**RESOLUTION AUTHORIZING AN AMENDMENT TO MASTER SALARY
RESOLUTION 077624 TO DELETE FIVE POSITIONS AND ADD SEVEN POSITIONS;
AND ACCEPT THE UPDATED REPORT OF BIWEEKLY SALARIES BY
CLASSIFICATION.**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

WHEREAS, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

WHEREAS, San Mateo County Ordinance No. 07303 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

NOW THEREFORE, IT IS HEREBY ORDERED that the Board of Supervisors authorizes an amendment to Master Salary Resolution 077624 as follows:

SECTION 2: Part 14 of the Resolution is amended as indicated:

ORGANIZATION 12600 AGRICULTURAL COMMISSIONER/SEALER

1. Item E350, Fiscal Office Specialist is decreased by 1 position for a new total of 0 positions.

2. Item E029, Administrative Assistant I is increased by 1 position for a new total of 1 position.

ORGANIZATION 30000 SHERIFF'S OFFICE

1. Item D088, Program Services Manager II is decreased by 1 position for a new total of 2 positions.
2. Item D049, Human Resources Manager I is increased by 1 position for a new total of 1 position.

ORGANIZATION 47300 FACILITIES SERVICES

1. Item T064S, Utility Worker Series is increased by 1 position for a new total of 10 positions.
2. Item T041S, Stationary Engineer Series is increased by 2 positions for a new total of 32 positions.

ORGANIZATION 66000 SAN MATEO MEDICAL CENTER

1. Item F107S, Electrograph Technician Series is decreased by 1 position for a new total of 1 position.
2. Item F075S, Radiologic Technician Series is increased by 1 position for a new total of 10 positions.
3. Item E411S, Patient Services Assistant Series is decreased by 1 position for a new total of 85 positions.
4. Item E413, Lead Patient Services Assistant is increased by 1 position for a new total of 7 positions.

5. Item F156, Laboratory Assistant II is decreased by 1 position for a new total of 7 positions.
6. Item F074S, Clinical Laboratory Scientist Series is increased by 1 position for a new total of 7 positions.
