RESOLUTION AUTHORIZING A ONE-TIME GRANT TO COASTSIDE HOPE TO SUPPORT THEIR CRITICAL NEEDS PROGRAM, PROVIDING FINANCIAL ASSISTANCE TO RESIDENTS IMPACTED BY LOSS OF INCOME, FOR A TOTAL AMOUNT NOT-TO-EXCEED \$20,000, AND AUTHORIZING THE COUNTY MANAGER, OR DESIGNEE, TO EXECUTE THE GRANT AGREEMENT

WHEREAS, Coastside Hope operates as a Core Agency and trusted County partner in Half Moon Bay providing contracted services as well as distributing funds from the San Mateo County Strong and the Immigrant Relief Fund; and

WHEREAS, many Coastside Hope clients have lost income unexpectedly

during a pandemic that disproportionately impacts people in low-income and rural

communities; and WHEREAS, many of the clients have been able receive

assistance from the San Mateo County Strong Fund and the Immigrant Relief Fund;

and

WHEREAS, these fund sources are unable to provide second-time grants;

and

WHEREAS, many of these Coastside Hope clients are essential workers in the agricultural industry; and

WHEREAS, these essential workers of San Mateo County require additional assistance in order maintain housing and food security for themselves and their families; and

WHEREAS, Coastside Hope, through its Critical Needs program, has provided some individual grants to assist these residents, but additional funds are needed to meet the needs of the community;; and

WHEREAS, the Board finds that retaining and supporting these essential workers and residents of San Mateo County during the COVID-19 pandemic is critical to community stability; and

WHEREAS, it is the Board's intent for the County Manager, or designee, to execute an agreement in the amount of \$20,000 to Coastside Hope and setting for the terms of the grant in furtherance of the objectives set forth in the Board transmittal; and

WHEREAS, this Board has been presented with a form of the agreement and has examined it and approved it as to both form and content and desires to enter into the agreement.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors approves of said grant, and authorizes the County Manager, or designee, to execute the agreement.

BE IT FURTHER RESOLVED that the County Manager or designee is authorized to execute amendments to the grant agreement which modify the County's maximum fiscal obligation by no more than ten percent (10%) or \$25,000 (in aggregate), whichever is less, and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
