**ADOPT A RESOLUTION WAIVING THE REQUEST FOR PROPOSALS PROCESS AND AUTHORIZING AGREEMENTS WITH ORRICK, HERRINGTON & SUTCLIFFE LLP FOR LEGAL SERVICES AS BOND COUNSEL, AND NORTON ROSE FULBRIGHT US LLP AS DISCLOSURE COUNSEL, IN CONNECTION WITH ANTICIPATED BOND ISSUANCES TO BE ISSUED WITHIN THE NEXT 18 MONTHS**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, the County desires the assistance of bond counsel and disclosure counsel in connection with the issuance of anticipated new and refunding bond issuances in the next 18 months; and

**WHEREAS**, the issuance of bonds presents unique legal and financial issues requiring specific expertise in bond financing and tax law and the disclosures to be made thereunder; and

**WHEREAS**, the County wishes to retain Orrick, Herrington & Sutcliffe LLP (“Orrick”), as bond counsel, and Norton Rose Fulbright US LLP (“Norton Rose”) as disclosure counsel, to provide such expertise and assistance, and a waiver of the Request for Proposals (“RFP”) process for these services is in the County’s best interests in light of these firms’ experience and expertise in prior County financings; and

**WHEREAS**, the proposed agreement with Orrick for bond counsel services with total compensation not to exceed \$525,000, and the proposed agreement and fee letter supplement with Norton Rose for disclosure counsel services with total compensation not to exceed \$150,000 have been presented to this Board for its consideration and acceptance, reference to which is hereby made

for further particulars, and the Board has examined and approved such agreements as to both form and content and desires to enter into the same.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the County requirement for a Request for Proposals process for bond counsel and disclosure counsel is hereby waived; and

**BE IT FURTHER RESOLVED** that the President of the Board is hereby authorized and directed to execute the agreements with Orrick, Herrington & Sutcliffe LLP and Norton Rose Fulbright US LLP for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto; and

**BE IT FURTHER RESOLVED** that the County Counsel, or designee, is authorized to execute contract amendments to each of the above-referenced agreements which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate per contract), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
