RESOLUTION AUTHORIZING AGREEMENTS WITH EAN SERVICES, LLC AND THE HERTZ CORPORATION FOR AN ON-CALL VEHICLE RENTAL SERVICES EACH FOR AN AMOUNT NOT TO EXCEED \$75,000 FOR THE TERM OF APRIL 4, 2021 THROUGH APRIL 5, 2024 WITH OPTIONAL TWO ONE-YEAR EXTENSIONS FOR A NOT TO EXCEED AMOUNT OF \$25,000 PER YEAR THROUGH APRIL 5, 2026 FOR A MAXIMUM TERM OF FIVE YEARS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the County Manager’s Office conducted an analysis of the County’s motor pool vehicle fleet and provided a series of recommendations to reduce the current motor pool fleet and establish a contract for an on-call vendor to augment vehicles on an as-needed basis; and

WHEREAS, the County of San Mateo Ordinance Code, Section 2.83.090(a) provides that the County can use an established Agreement, provided it meets the purchasing requirements; and

WHEREAS, the United States General Services Administration (GSA) has established a Rental Supplemental Vehicles Program (RSVP) for vehicle rentals to augment fleet needs and has established a Multiple Award Schedule (MAS) with several vendors; and

WHEREAS, the County's Procurement Department has reviewed and approved the use of GSA's Multiple Award Schedule; and

WHEREAS, the Department of Public Works (Department) solicited Request for Quotes from vendors identified in GSA's Multiple Award Schedule; and

WHEREAS, EAN Services, LLC (operating as Enterprise, National, Alamo Car Rental) and The Hertz Corporation (operating as Hertz, Dollar Car Rental, Thrifty Car Rental) submitted quotes to provide vehicle rentals to the County on an as-needed basis; and

WHEREAS, it is in the best interest of the County of San Mateo to enter into agreements with the two vendors to provide the Department with vehicle rental services to meet the County's vehicle demands; and

WHEREAS, this Board has approved the On-Call Vehicle Rental Services Agreements as to both form and content and desires to enter into these Agreements.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors be and is hereby authorized and directed to execute separate agreements with EAN Services, LLC, and the Hertz Corporation for and behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto.
