**RESOLUTION AUTHORIZING AN AMENDMENT TO MASTER SALARY
RESOLUTION 077624 TO SET THE SALARY OF THREE CLASSIFICATIONS,
DELETE FOUR POSITIONS, AND ADD FOUR POSITIONS; AND ACCEPT THE
UPDATED REPORT OF BIWEEKLY SALARIES BY CLASSIFICATION**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

WHEREAS, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

WHEREAS, San Mateo County Ordinance No. 07303 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

NOW THEREFORE, IT IS HEREBY ORDERED that the Board of Supervisors authorizes an amendment to Master Salary Resolution 077624 as follows:

SECTION 1: Part 14 of the Resolution is amended as indicated:

ORGANIZATION 30000 SHERIFF'S OFFICE

1. Salary for Item B309, Deputy Director of NCHIDTA/NCRIC-Unclassified is set at \$70.84 to \$88.56 per hour.

2. Salary for Item B307, NCHIDTA/NCRIC Medical Liaison Officer-Unclassified is set at \$58.28 to \$72.85 per hour.

ORGANIZATION 32000 PROBATION DEPARTMENT

1. Item E006, Administrative Secretary III-Confidential is decreased by 1 position for a new total of 3 positions.

ORGANIZATION 61000 BEHAVIORAL HEALTH AND RECOVERY

1. Item G098S, Social Worker/Children's Services Social Worker Series is decreased by 1 position for a new total of 0 positions.
2. Item G226S, Community Program Specialist Series is increased by 1 position for a new total of 2 positions.
3. Item G240S, Case Management/Assessment Specialist Series is increased by 1 position for a new total of 16 positions.

ORGANIZATION 66000 SAN MATEO MEDICAL CENTER

1. Item D182S, Management Analyst Series is decreased by 1 position for a new total of 11 positions.
2. Item D168, Assistant Medical Director is increased by 1 position for a new total of 2 positions.
3. Salary for Item S021, Dietitian II is set at \$40.79 to \$51.00 per hour.
