

**AMENDMENT TO AGREEMENT**

**BETWEEN THE COUNTY OF SAN MATEO AND THE CENTER TO PROMOTE  
HEALTH CARE ACCESS, INC., PREVIOUSLY DOING BUSINESS AS SOCIAL  
INTEREST SOLUTIONS, now ALLUMA**

THIS AMENDMENT TO THE AGREEMENT, entered into this 01 day of July, 2021,  
by and between the COUNTY OF SAN MATEO, hereinafter called "County," and THE  
CENTER TO PROMOTE HEALTH CARE ACCESS, INC. previously doing business as  
SOCIAL INTEREST SOLUTIONS, INC., now ALLUMA, hereinafter called "Contractor";

**W I T N E S S E T H:**

WHEREAS, pursuant to Government Code, Section 31000, County may contract with  
independent contractors for the furnishing of such services to or for County or any Department  
thereof;

WHEREAS, the parties entered into an Agreement whereby Contractor provides a local  
eligibility system using One-e-App Software that supports the San Mateo County Health  
System's role in conducting outreach , eligibility screening, enrollment and retention in local  
health coverage programs for eligible low-income residents on May 20, 2014; and

WHEREAS, the parties amended the Agreement on January 26, 2016; and

WHEREAS, the parties amended the Agreement on August 9, 2016; and

WHEREAS, the parties amended the Agreement on September 12, 2017; and

WHEREAS, the parties amended the Agreement on July 10, 2018; and

WHEREAS, the parties wish to amend the Agreement to increase the amount of the agreement by \$124,080 to \$1,085,621 and change the term to January 1, 2014 through June 30, 2022.

1. Exhibit B, letter 'A' of the agreement is amended to add Section F. as follows:

F. The total amount of this agreement is not to exceed ONE MILLION EIGHTY FIVE THOUSAND SIX HUNDRED TWENTY ONE DOLLARS (\$1,085,621).

2. Exhibit B, letter 'A' of the agreement is amended to add Section F. as follows:

F. Between July 1, 2021 and June 30, 2022 Contractor shall invoice for system maintenance based on the following fee schedule:

The specific invoice payments are as follows:

- i. If the total number of consumers during the past three months is greater or equal to 20,000 enrollees per month, the Contractor shall be paid a total of TEN THOUSAND THREE HUNDRED FORTY DOLLARS (\$10,340) for that month.
- ii. If the total number of consumers during the past three months is greater than or equal to 15,000 but less than 20,000 enrollees per month, the Contractor shall be paid a total of NINE THOUSAND SIX HUNDRED FORTY SEVEN DOLLARS (\$9,647) for that month.
- iii. If the total number of consumers during the past three months is greater than or equal to 10,000 but less than 15,000 enrollees per month, the Contractor shall be paid a total of SEVEN THOUSAND SIX HUNDRED FORTY FIVE DOLLARS (\$7,645) for that month.
- iv. If the total number of consumers during the past three months is greater than or equal to 5,000 but less than 10,000 enrollees per month, the Contractor shall be paid a total of SIX THOUSAND ONE HUNDRED FIVE DOLLARS (\$6,105) for that month.
- v. If the total number of consumers during the past three months is greater than or equal to 2,500 but less than 5,000 enrollees per month, the Contractor shall be paid a total of FOUR THOUSAND ONE HUNDRED FORTY ONE DOLLARS (\$4141) for that month.
- vi. If the total number of consumers during the past three months is less

than 2,499 enrollees per month, the Contractor shall be paid a total of  
THREE THOUSAND FIVE HUNDRED SIXTY FOUR DOLLARS  
(\$3,564) for that month.

3. **All other terms and conditions of the agreement dated July 10, 2018, between the County and Contractor shall remain in full force and effect.**
