

**AMENDED MEMORANDUM OF UNDERSTANDING
BETWEEN SAN MATEO COUNTY BEHAVIORAL HEALTH AND RECOVERY
SERVICES DIVISION AND AHMC HEALTH**

The purpose of this Amended Memorandum of Understanding (MOU) is to describe and make explicit the agreement between the San Mateo County Behavioral Health and Recovery Services Division and AHMC Health regarding the designation of AHMC as a 5150 facility.

2. Background Information

Through this MOU, San Mateo County Behavioral Health and Recovery Services Division (BHRS) designates AHMC Health as a 5150 facility. The designation allows AHMC Health to receive patients on a 5150 hold that meet AHMC Health's admissions criteria and are in need of treatment at a geropsychiatric facility. The designation authorizes AHMC Health to provide psychiatric evaluation and treatment of persons on a 5150 hold that can be served by the program and meet the admissions criteria as determined by AHMC Health. This designation conforms to the requirements of BHRS Policy 90-09: 5150 Designated Facilities, and California Welfare & Institutions Code Section 5150, which are incorporated into this Agreement by reference herein.

3. Term and Termination

3.1 Term

Subject to compliance with all terms and conditions, the term of this Agreement shall be from January 1, 2021 through December 31, 2021. This Agreement will automatically renew annually for a one-year term upon review by the BHRS Designated Facility Review Team.

3.2 Amendment/Modification Process

All subsequent modifications or amendments shall be in writing and signed by the parties.

3.3 Termination

This MOU may be terminated by either party at any time without a requirement of good cause upon thirty (30) days' written notice to the other party.

4. Applicability of Designation

The designation is only valid if AHMC Health's Geriatric Behavioral Health Unit is State licensed, approved by the County of San Mateo, satisfies any and all conditions set forth within, and satisfactorily completes an annual review conducted by the BHRS Designated Facility Review Team.

4.1 Annual Review

The annual review will include at a minimum review of the treatment milieu of the facility, discharge procedures and plans, patients' rights procedures, medication monitoring, and quality of care issues. The annual review may result in the formulation of plans for improving any situation which needs attention and AHMC Health will participate in the plan development and comply with any requirements of the plan.

5. Regulations Compliance

AHMC Health shall comply with all applicable Federal and State regulations, and BHRS Policies & Procedures, including, but not limited to:

- a. File quarterly report (DHCS 1010: Involuntary Detentions Reporting Form (Attachment 1)) for disclosing involuntary detentions to the County.
- b. Maintain appropriate activities that afford patient due process, such as access to the Patients' Right Advocate, a process and location for 5250 hearings, Riese Hearings, and other applicable activities required as part of the patient's protection rights.
- c. Acquire and maintain staff certification for writing 5150 holds.

6. Conditions of Designation

The 5150 Designation for AHMC Health includes the following conditions that must be met during the period in which the designation is valid.

6.1 Coordination of Care

AHMC Health operates the Geriatric Behavioral Health Unit, a hospital-based Skilled Nursing Facility (SNF), and a community-based SNF, all of which play a critical role in the continuum of care for patients with a mental health diagnosis with high regard for state of the art treatment and care. AHMC Health shall strive to coordinate care with the County of San Mateo in an effort to comprehensively meet the needs of our communities, which may include acceptance of patients into placement into the range of facilities operated by AHMC Health. Such placements will be appropriate, meet the criteria established by AHMC, and not current patients of San Mateo Medical Center (SMMC) 3A/B (Inpatient). AHMC Health reserves

the right to not accept said patients but will endeavor to accept patients when appropriate.

6.2 Quarterly Meeting

To facilitate ongoing communication between BHRS and AHMC Health a condition of this designation is for the two parties to meet no less than quarterly to discuss at a minimum, designation issues, inpatient issues, client flow, claims, compliance matters, and other issues that may arise from time to time. Meetings will be held at the main hospital campus. Minimum meeting attendees include the Medical Director and/or Deputy/Assistant Medical Director for BHRS and AHMC Health, Program Director for the Geriatric Behavioral Health Unit, AHMC Health Administration Representative, and the BHRS Assistant Director.

6.3 Out-of-County Placements

Patients admitted to the Geriatric Behavioral Health Unit from counties other than the County of San Mateo, shall be discharged back to the placing County or County of Residence from the Unit or other necessary levels of care. Under no circumstances shall out of county placements become the responsibility of the County of San Mateo. Any transportation costs associated with these placements will not be borne by the County.

6.4 Admission Criteria

Psychiatric holds may only be transported to AHMC Health if the patient meets admission criteria and AHMC concurs with the transfer or is transferred internally within the AHMC Health system of care due to the specialization of the program. Under no circumstances shall law enforcement transport 5150 Holds to AHMC Health unless AHMC Health authorizes acceptance of the patient on the hold. Law enforcement and others authorized to issue a 5150 Hold should always coordinate with the San Mateo Medical Center Psychiatric Emergency Services as the entryway to the County Inpatient System of Care. Holds issued by law enforcement for agencies in the northern portion of the County can be transported to Mills Peninsula Hospital and Psychiatric Emergency Services. AHMC Health shall provide upon receipt of this designation the admission criteria for the Geriatric Behavioral Health Unit to the County and upon any changes to the criteria and within 30 days of the criteria change.

Upon admission to the inpatient unit, the BHRS Hospital Liaison will make contact with AHMC Health staff to establish communication with the County and coordinate placement to lower levels of care. To the extent feasible, the BHRS Hospital Liaison will assist with the referral of patients to AHMC Health from either SMMC PES or Mills-Peninsula PES in the County using the admission criteria.

6.5 Discharge Planning

When patients are residents of the County of San Mateo and known to BHRS, staff at the Geriatric Behavioral Health Unit will contact the BHRS ACCESS Call Center prior to discharge in order to coordinate care across the levels of care. When discharging a patient with medications prescribed by AHMC Health during the inpatient stay, staff shall provide for a doctor to doctor consult. Doctor to doctor consults can be scheduled through the ACCESS Call Center or the Therapist on Duty at a County Regional Clinic, if the client is known to the clinic.

When patients are residents of the County of San Mateo and known to BHRS, the Discharge Planning Instructions, Attachment 2, shall be followed by AHMC Health. To assist with the identification of patients that are residents of San Mateo County and known to BHRS, the County shall provide access and basic training to the BHRS Electronic Health Record. Users granted access shall meet credentialing criteria and are subject to all local, state, and federal regulations concerning confidentiality, HIPAA, and protected health information.

6.6 Training and Certification

AHMC Health shall assure that staff working the Geriatric Behavioral Health Unit have been trained and certified to write 5150 Holds in sufficient numbers so that no work shift is without properly trained and certified staff. AHMC Health shall work with the County to maintain an adequate number of trained and certified staff ongoing.

6.7 Specialty Psychiatric Health Facility

The County of San Mateo recognizes that AHMC Health operates a specialty geriatric behavioral health unit designed to treat persons 55 years of age and older and that patients admitted into this facility will meet the age requirement and other admissions criteria. AHMC Health recognizes that as a designated facility, the specialty geriatric behavioral health unit operates within a greater network of inpatient facilities in the County of San Mateo.

Along with the San Mateo Medical Center and Mills Peninsula Hospital, AHMC Health brings services to this network for older adults. Mills Peninsula Hospital brings services to this network for children and youth. The AHMC Health operates as the hub of this network of inpatient care and as the safety net for those who may not otherwise afford care. This creates an expectation that AHMC Health coordinate with this network as may be necessary and in ways that satisfy the individual charge of AHMC Health and the other hospitals in this network so as to assure that County residents receive coordinated care in the most appropriate facility if available at the time of placement. This does not create a requirement that AHMC Health must accept transfers from within this network, only to the extent that such a transfer would benefit County residents and satisfy the

requirements of AHMC Health. This creates an expectation that AHMC Health actively participate in the local network to help plan and coordinate inpatient services generally.

6.8 Compliance and Conditions

The County of San Mateo shall monitor compliance with the conditions set forth in this document through the BHRS Compliance Officer. Results of the ongoing monitoring shall be reported and discussed at the regular quarterly meetings. Such issues may result in a plan of correction, which if necessary, will be developed by AHMC Health and submitted to the Compliance Officer for review and approval.




