AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND ABODE SERVICES

THIS AMENDMENT TO THE AGREEMENT, entered into this day of
, 20, by and between the COUNTY OF SAN MATEO, hereinafter
called "County," and Abode Services, hereinafter called "Contractor";
<u>WITNESSETH</u> :

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof; and

WHEREAS, the parties entered into an Agreement (the "Agreement") for the purpose of CalWORKS Housing Support Program and Rapid Rehousing services on July 7, 2020 for the term of July 1, 2020 through June 30, 2023 and for a total obligation amount not to exceed \$7,801,791; and

WHEREAS, the parties wish to amend the Agreement to add \$323,522.38 in funding for a revised total obligation amount not to exceed. \$8,125,313.38.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

- 1. The fourth WHEREAS clause on page 1 of the Agreement under the Section entitled "Witnesseth" is amended to read as follows:
 - 1. Amount of Federal funds obligated by this action to subrecipient: \$8,125,313.38
 - 2. Indirect Cost Rate for Federal Award: 10%
 - 3. This is not a Research and Development Award
- 2. Section 4. Payments, paragraph 1 of the Agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions and specifications set forth herein and in Exhibits A and C, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed EIGHT MILLION, ONE HUNDRED TWENTY-FIVE THOUSAND, THREE HUNDRED THIRTEEN DOLLARS AND THIRTY-EIGHT CENTS (\$8,125,313.38).

3.	All other terms and conditions of the Agreement dated July 7, 2020, between County and Contractor shall remain in full force and effect.
