WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof; and

WHEREAS, on October 20, 2020, the parties entered into an agreement ("Agreement") for the term of October 1, 2020, through September 30, 2023 for a total obligation amount of \$215,850 to provide maintenance and technical support for the QUEST application; and

WHEREAS, the parties wish to amend the Agreement to increase funding by \$30,000 for a new total obligation amount not to exceed \$245,850 with the same term of October 1, 2020, through September 1, 2023, to make system enhancements to improve reporting capabilities.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Paragraph 1. Payments is hereby amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed TWO HUNDRED FORTY-FIVE THOUSAND EIGHT HUNDRED FIFTY DOLLARS (\$245,850). In the event that County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount

- owed by County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement
- 2. All other terms and conditions of the Agreement dated October 20, 2020, between County and Contractor shall remain in full force and effect.
