compensation and benefits of County officers and employees; and

WHEREAS, San Mateo County Ordinance No. 07303 ordered that henceforth

the number of County appointed officers and employees and their compensation and

benefits shall be established by resolution of the Board of Supervisors; and

NOW THEREFORE, IT IS HEREBY ORDERED that the Board of Supervisors

authorizes an amendment to Master Salary Resolution 078309 as follows:

SECTION 1: Part 14 of the Resolution is amended as indicated:

ORGANIZATION 30000 SHERIFF'S OFFICE

- Item B221, Management Analyst-Unclassified is decreased by 1 position for a new total of 0 positions.
- Item D182S, Management Analyst Series is increased by 1 position for a new total of 11 positions.

ORGANIZATION 61000 BEHAVIORAL HEALTH AND RECOVERY SERVICES

- Item G081, Mental Health Program Specialist is decreased by 1 position for a new total of 18 positions.
- Item F005, Supervising Mental Health Clinician is increased by 1 position for a new total of 26 positions.

ORGANIZATION 66000 SAN MATEO MEDICAL CENTER

- Item D182S, Management Analyst Series is decreased by 2 positions for a new total of 9 positions.
- 2. Item D107, Hospital and Clinics Finance Manager is increased by 1 position for a new total of 3 positions.
