

#### **County Context**

- At least 64% People of Color
  - Approximately 67% People of Color per Dr. Benner (UC Santa Cruz)
- Large Immigrant Community
  - 35% foreign born. 21% of immigrant population undocumented.
  - 46% speak another language at home
  - 57% of children have immigrant parents



# Inequities by Race are Pervasive

- Life expectancy gap between Black and White is 4 years.
- Overcrowding is over 11x higher in Latinx and PI populations, and between 2x and 5x higher in the Black, Asian and AI/AN population, than the White population
- Home ownership is over 1.5x higher for White and Asian households versus Pacific Islander, Latinx, American Indian/Alaska Native, and Black
- Median HH income for White and Asian HH is 2x that of Black and Latinx HHs
- Food stamps are used over 4x more by Latinx, PI, Black, and AI/AN than White households
- Unemployment is higher in the Asian, Latinx, PI, and AI/AN communities than the White community
- COVID cases have disproportionally impacted communities of color and vaccination rates are lower in communities of color

# Why start with race?

- Leading with race but not exclusively focused on race
- Racism and White Supremacy are embedded into the founding of the United States and were built into structures and systems of operation
- Race is a key determinant in the majority of life outcomes
- Racism runs deep within other forms of oppression patriarchy and sexism, heteronormaty, ageism, ableism, transfobia, classism and more
