AMENDMENT 1 TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND MIKASOFT, INC.

THIS AMENDMENT 1 TO THE AGREEMENT ("Amendment"), entered into this 5th day of October 2021, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and MIKASOFT INC., hereinafter called "Contractor".

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement to provide consulting and project management services for the Assessor Property Assessment System (APAS), on June 25, 2019 (Resolution No. 076721), as amended hereinafter called "Agreement"; and

WHEREAS, the parties wish to amend the Agreement (Amendment 1) to extend the term by an additional nine months from January 01, 2022 to September 30, 2022 and covering overtime expenses for the period of July 01, 2019 through July 31, 2021 and increase the Agreement amount by \$385,000 to a new not to exceed amount of \$1,344,508.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. The third sentence of Section 3: Payments: of the Agreement is amended to read as follows:

"In no event shall County's total fiscal obligation under this Agreement exceed One Million Three Hundred Forty-Four Thousand Five Hundred Eight dollars (\$1,344,508)."

2. <u>Section 6: Term:</u> of the Agreement is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from July 1, 2019, through September 30, 2022.

3. Second paragraph of Exhibit B: of the Agreement is amended to read as follows:

The combined total hours for this contract will not exceed 7199 hours. The hours are broken down as 6770 regular hours which will be spread over the 39-month term of the

contract and a contingency for overtime hours of 429 during the 39-month contract. Invoices will be submitted based on hours worked (\$180 per hour FY2019-2020, \$186 per hour FY2020-2021, \$191 per hour FY2021-2022, and \$197 per hour FY2022-2023) during each two-week period. Terms are net 30 days after invoice is approved.

4. All other terms and conditions of the agreement dated June 25, 2019, between the County and Contractor shall remain in full force and effect.
