### CoD 2021 Challenges

- Due to the pandemic, several events which usually help educate, advocate and celebrate the disabilities community were cancelled, including the Annual Inclusion Festival, Art Showcase, and ADA Anniversary Celebration.
- Due to health and safety protocols, the ADA Compliance
   Commission was unable to perform its usually site visits of Transition Plan Projects.
- Many of the CoD's initiatives which involve public participation were put on hold due the shelter in place mandate

### Compliance Committee

#### **ADA Title II Coordinator**

- In May 2019 –The CoD approved a model job description (as a full-time position in the County Manager's Office).
- In January 2020 County HR was ready to begin recuitment for the ADA Title II Coordinator Position when the Pandemic essentially put on hold on this indefinitely
- Currently County HR is in the process or re-opening recruitment
- Much of the work related to the County Transition Plan hinges on the filling of this position

2021 Committee Goals

- 1. Advise the County's Commission on Disabilities and the Board of Supervisors on the accessibility needs of County-owned, or leased property and facilities. To work with all the departments within the County to assure equal public access to facilities and programs as defined by the Americans with Disabilities Act (ADA).
- 2. Work to monitor and update the Transition Plan
- Help educate County employees about the ADA.

### 2021 Committee Objectives

- 1. Continue partnering with the various County divisions in removing barriers throughout the County, these divisions include but are not limited to:
  - 1. Department of Public Works
  - Health System
  - 3. Human Services
  - Elections Office
- 2. Establish a priority list for removal of barriers
- Continue to monitor the new Title II coordinator position moving forward

### Committee Area of Focus:

Hate Crimes & Abuse Against People with Disabilities

#### **2020-2021 Updates**

- Created Abuse Roundtable Group (ARG) in partnership with DA's Office Victim Services Division; focus on prevention and reporting of abuse & prosecution of abusers
- ARG met five times since February 2020; most recently on September 29, 2021
- This group involved over 30 agencies, offices and organizations representing law enforcement, non-profits, legislative officials, government and direct service providers

Hate Crimes & Abuse Against People with Disabilities

#### 2020-2021 Updates continued:

- ARG workgroup on Training for Law Enforcement collaborated with a local Crisis Intervention Team training group and expanded time focused on disabilities to 2 hours
- An article on the ARG was published in a local newspaper
- Several commissioners and other ARG participants were featured in a panel for a San Mateo Police Department YouTube series titled *Real Talk San Mateo*. This episode focused on law enforcement interactions with the disabilities community and was mentioned in a local newspaper.

Committee Goal Empower the disabilities community through awareness training, supporting victims and allies in reporting abuse, & continuing to educate direct service providers about signs of abuse and mandated reporting

Committee Objectives

- Coordinate Monthly Presentations at CoD General Meetings
- Continue to advocate regarding gaps in services for the disabilities community
- 3. Continued review of legislation impacting disability community
- 4. Work with members of the ARG in finding ways to educate the public and bring justice to victims

- Focused on 0-5 age groups by gathering program information and resources
- Compiled resources for families to assist in addressing special education and support services, especially during COVID (and ongoing impacts)
- Created resource material to distribute and share with families

Coordinate with the Transition to Independence Fair (TIF) organizers to implement year-round engagement with the community of persons with disabilities aged 14-22 in order to share resources

#### Goal #3

Create space for youth with disabilities and their families & allies to develop messaging around a *shared presumption* of competency, high expectations for success, personcentered planning and strengths-based practices in school and community settings to promote greater success of all persons with disabilities.
