

**AMENDMENT NO. FOUR TO AGREEMENT  
BETWEEN THE COUNTY OF SAN MATEO AND  
AECOM TECHNICAL SERVICES, INC.**

THIS AMENDMENT TO THE AGREEMENT, entered into this \_\_\_\_day of \_\_\_\_\_, 20\_\_\_\_, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and AECOM, Technical Services, Inc., hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement on May 19, 2015 for engineering and other professional and technical services, in an amount of \$1,729,061, for the term of May 19, 2015 through May 18, 2018; and

WHEREAS, the Director of Public Works approved Amendment No. One to the Agreement, which extended the term through June 30, 2019 with no change to the agreement amount; and

WHEREAS, the Director of Public Works approved Amendment No. Two to the Agreement, which extended the term through December 31, 2022 with no change to the agreement amount; and

WHEREAS, on October 22, 2019, the Board of Supervisors approved Amendment No. three to the Agreement to increase the Agreement amount by \$342,498 to \$2,071,559; and

WHEREAS, the parties wish to amend the Agreement to increase the Agreement amount by \$236,625 to \$2,308,184.

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:**

1. Section 3. Payments of the Agreement is amended to read as follows:  
In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth herein and in Exhibit A, County shall make payment to the Contractor based on the rates and in the manner specified in Exhibit D, Contractor Budget and Fees for Amendment No. Four attached hereto and made part of Amendment No. Four. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed Two Million Three Hundred Eight Thousand One Hundred Eighty-Four and No/Dollars (\$2,308,184).
2. All other terms and conditions of the Agreement dated May 19, 2015 between the County and Contractor shall remain in full force and effect.
