RESOLUTION AUTHORIZING AGREEMENTS WITH: A) ENNEAGRAM PRISON PROJECT FOR SERVICES TO JUSTICE-INVOLVED INDIVIDUALS WHO ARE BOTH IN- AND OUT-OF-CUSTODY FOR THE TERM JULY 1, 2021 THROUGH JUNE 30, 2022, IN AN AMOUNT NOT TO EXCEED \$351,522; AND B) JOBTRAIN FOR SERVICES TO JUSTICE-INVOLVED INDIVIDUALS WHO ARE BOTH IN- AND OUT-OF-CUSTODY FOR THE TERM JULY 1, 2021 THROUGH JUNE 30, 2022, IN AN AMOUNT NOT TO EXCEED \$615,000; AND C) SERVICE LEAGUE OF SAN MATEO COUNTY TO JUSTICE-INVOLVED INDIVIDUALS WHO ARE BOTH IN- AND OUT-OF-CUSTODY FOR THE TERM JULY 1, 2021 THROUGH JUNE 30, 2022, IN AN AMOUNT NOT TO EXCEED \$797,773; AND D) PROJECT READ FOR SERVICES TO JUSTICE-INVOLVED INDIVIDUALS WHO ARE OUT-OF-CUSTODY FOR THE TERM JULY 1, 2021 THROUGH JUNE 30, 2022, IN AN AMOUNT NOT TO EXCEED \$53,500; AND E) PENINSULA CONFLICT RESOLUTION CENTER FOR SERVICES TO JUSTICE-INVOLVED INDIVIDUALS WHO ARE IN-CUSTODY FOR THE TERM JULY 1, 2021 THROUGH JUNE 30, 2022, IN AN AMOUNT NOT TO EXCEED \$150,000

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the County Manager's Office and the Sheriff's Office issued a joint Request for Proposals (RFP) for programs and services for the County's justice-involved population, reflecting the County's commitment to linking in-custody programs and services and out-of-custody service continuation; and

WHEREAS, the RFP reflected the main strategies found in the Community

Corrections Partnership (CCP) Local Implementation Plan (LIP) adopted by this Board in 2012 and revised in 2020; and

WHEREAS, this Board wishes to approve an agreement with the Enneagram

Prison Project pursuant to which that contractor will teach inmates to identify, observe,

and self-regulate their behavioral and emotional patterns, thereby increasing their ability to make conscious, positive changes and choices during their incarceration and upon release; and

WHEREAS, this Board wishes to approve an agreement with JobTrain pursuant to which that contractor will provide Work Readiness, Success Coaching, ServSafe Certification, Culinary Arts and Hospitality, and a Construction Pre-Apprenticeship Program to inmates, thereby helping them to develop marketable skills and to prepare them to enter the workforce upon release, and will also provide ex-offenders with multiple career pathways, including partnering with Community Legal Services East Palo Alto, to assist ex-offenders in obtaining employment and avoid recidivism; and

WHEREAS, this Board wishes to approve an agreement with Service League of San Mateo County pursuant to which that contractor will provide direct services to inmates, such as jail programming, jail orientation, counseling, referrals, jury trial clothing, childcare, Spanish language services, and various denominational chaplaincy services to inmates, and post-release services such as travel fare, food, and Sober Living/Transitional Housing services to ex-offenders; and

**WHEREAS**, this Board wishes to approve an agreement with Project READ, pursuant to which that contractor will provide services to ex-offenders who are out-of-custody and who are referred by the County's Service Connect program for literacy services; and

WHEREAS, this Board wishes to approve an agreement with Peninsula Conflict Resolution Center pursuant to which that contractor will teach Conflict Transformation

and Anger Management services to inmates in the County's adult correctional facilities; and

WHEREAS, there has been presented to this Board of Supervisors for its consideration and acceptance, agreements with Enneagram Prison Project, JobTrain, Service League of San Mateo County, Project READ, and Peninsula Conflict Resolutions, each for the term July 1, 2021 through June 30, 2022 in a collective total amount not to exceed \$1,967,795; and

**WHEREAS**, this Board has considered and approved these agreements as to both form and content and desires to enter into them.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors be and is hereby authorized and directed to execute said agreements for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the County Manager or designee is authorized to execute amendments to the agreements which modify the County's maximum fiscal obligation as to each agreement by no more than \$25,000 (in aggregate per agreement), whichever is less, and/or modify the contract terms and/or services so long as the modified term s or services is/are within the current or revised fiscal provisions.
