

**THIRD AMENDMENT TO AGREEMENT  
BETWEEN THE COUNTY OF SAN MATEO AND  
CHILD CARE COORDINATING COUNCIL OF SAN MATEO COUNTY, INC.**

THIS AMENDMENT TO THE AGREEMENT, entered into this \_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and the Child Care Coordinating Council of San Mateo County, Inc., hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, on June 25, 2019, the parties entered into an agreement (the "Agreement") for providing CAPP child care services in a total amount not to exceed \$3,000,000 for the term of July 1, 2019 through June 30, 2022; and

WHEREAS, on May 17, 2021, the parties amended the Agreement to add funds in the amount \$12,505.72 of from Senate Bill ("SB") 820, which provided an update to the 2020 Budget Act, for a revised total obligation amount not to exceed \$3,012,505.72; and

WHEREAS, on June 29, 2021, the parties further amended the Agreement to add funds in the amount of \$53,471.25 from SB 820 for a revised total obligation amount not to exceed \$3,065,976.97; and

WHEREAS, the parties now wish to further amend the Agreement to add additional funds in the amount of \$2,150,000 in additional CAPP provider payments for a new total obligation amount not to exceed \$5,215,976.97.

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:**

1. **Section 4. Payments**, paragraph 1 of the Agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions and specifications set forth herein and in Exhibits A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibits B. The County reserves the right to withhold payment if the County determines that the quantity or quality of the work performed is unacceptable. In no event shall the County's total fiscal obligation under this Agreement exceed FIVE MILLION, TWO HUNDRED

FIFTEEN THOUSAND, NINE HUNDRED SEVENTY-SIX DOLLARS AND NINETY-SEVEN CENTS (\$5,215,976.97).

- 2. All other terms and conditions of the Agreement dated June 25, 2019, as amended on May 17, 2021 and June 29, 2021, between County and Contractor shall remain in full force and effect.**

**THIS CONTRACT IS NOT VALID UNTIL SIGNED BY ALL PARTIES. NO WORK WILL COMMENCE UNTIL THIS DOCUMENT HAS BEEN SIGNED BY THE COUNTY PURCHASING AGENT OR AUTHORIZED DESIGNEE.**
